• Details of current policies/guidance in place in respect of the Decision Making Process;

• Information on the number of member delegated decisions and their type (key/non key);

• Information on the number of officer delegated decisions taken; and

• Information on the activities of the governance team (communications, training/ awareness raising).

## Update

- 6. The Council's Decision Making Process is currently subject to an audit. The outcome of the audit will be reported to a future meeting of the Committee.
- 7. Following the previous audit, a number of improvements to the Decision Making Process have been made. The Officer Delegated Decision Form has been amended so that a more in depth audit with regard to when the decision was loaded on to the system, which officer completed the form on the system and which officer published the form, with the corresponding dates able to be identified for each part of the process. A copy of the Revised Officer Delegated Decision Form is attached at **Appendix A**.
- 8. A Decision Making Masterclass was developed and the first Masterclass was held on 17 September 2019 which was open to all Managers.
- 9. The E-Learning Module on Decision Making is to be reviewed to make it more concise.
- 10. A report containing details of Officer Delegated Decisions taken during the period 1 January 2019 31 December 2019 is attached at **Appendix B**.
- 11. A report containing details of Executive decisions taken during the period 1 January 2019 - 31 December 2019 is attached at **Appendix C**.
- 12. A report detailing all outstanding Executive decisions is emailed to the

Leadership Management Team on a monthly basis, to assist in the monitoring process. This provides LMT with details of all Executive decisions that have not yet been implemented. The report details the actual date for completion and outlines whether the action required to implement the decision is on target for completion or off target.

- 13. **Scrutiny and challenge** since 1 January 2019 there have 86 Executive decisions. In the corresponding period, the Council received 4 requests for call-in, in respect of the following:
  - Middlesbrough Place Brand Decision not to refer back to Executive Southlands Centre Future Redevelopment - Decision not to refer back to Executive
  - Acquisition Homes England Land at Middlehaven
  - Long Term lease of Gresham site Thirteen Group Referred back to Executive. Reconsidered by Executive - Decision was to implement recommendations contained in the original Executive report and not to approve any of the recommendations made by the Overview and Scrutiny Board.

## **Council Constitution**

- 14. The Council's Constitution sets out how the Council operates, how decisions are made and the procedures which are followed to ensure that these are efficient, transparent and accountable to local people. Some of these processes are required by the law, while others are a matter for the Council to choose.
- 15. The Constitution is divided into 18 articles which set out the basic rules governing the Council's business. More detailed procedures and codes of practice are provided in separate rules and protocols at the end of the Constitution.
- 16. The Council's Constitution is a living document and is currently subject to review.
