#### **BACKGROUND AND EXTERNAL CONSULTATION**

- 5. Each Local Authority which provides a fostering service and/or acts as an adoption agency is required to establish a panel consisting of social work practitioners experienced in adoption and family placement matters, elected Members and independent persons. The composition of the panel is prescribed by the Adoption Agencies Regulations 2005 and the Fostering Services Regulations 2002.
- 6. Middlesbrough Council has established a Family Placement Panel, which meets the legal requirements in relation to fostering and adoption and therefore can consider cases from both aspects of family placement work. The Panel plays a key role in promoting the welfare of vulnerable children in public care.
- 7. The Panel has 10 members and is serviced by officers from the Legal Department, Members' Office and the Family Placement Service. It normally meets fortnightly for half a day.
- 8. The role of the Family Placement Panel is to consider:
  - applications from prospective adopters
  - plans for children to be placed for adoption
  - proposals to place a specific child or children for adoption by particular prospective adopters
  - reviews of the approval of prospective adopters
  - applications from prospective foster carers
  - > reviews of the approval of foster carers
  - plans for children to be placed in long-term foster care
  - proposals to place a specific child or children in a long-term foster placement with particular foster carers.
  - termination of the approval of foster carers.
  - applications for approval as supported lodgings providers

## ACTIVITY FROM 1st APRIL TO 30TH SEPTEMBER 2009

- 9. The Family Placement Panel met on 19 occasions during this period. The matters considered by the panel are often complex and at times meetings can be lengthy and demanding. Panel members receive the papers in advance of each meeting and need to read them thoroughly prior to the meeting in order to participate effectively in the discussion.
- 10. The number of items considered in each category during this 6 month period were as follows:

- 11. It will be noted that 1 foster carer was de-registered during this period and the reason for deregistration was related to concerns about the standard of care provided.
- 12. For comparison purposes, the table overleaf shows items considered by the Panel over an 18 month period. This table clearly shows the increase in the workload of Panel since April 2009, with a 62% increase in the number of items considered when compared with the previous 6 month period. The number of meetings has also increased, although not by the same amount, and many of the meetings have been very lengthy and demanding for Panel members.

13. It will be noted that the number of new foster carers approved during the last 18 months has been low. On a positive note however, recent recruitment campaigns have resulted in an increased number of applications which are currently being processed and these should result in some new approvals in the next few months.

# **EQUALITY IMPACT ASSESSMENT**

14. All social care services are delivered within a framework of anti-discriminatory practice and there are no specific issues arising from the information presented within this report.

16. There are no immediate financial or legal implications in this report. There are no specific ward implications as the work of the Family Placement Panel covers the whole of Middlesbrough.

## **RECOMMENDATION**

17. It is recommended that the Corporate Parenting Board advise the Executive to note the information relating to the Family Placement Panel.

#### **REASONS**

- 18. This recommendation is supported by the following reasons:
  - (a). Standard 17.3 of the National Minimum Standards for Local Authority Adoption Services in England requires the executive side of the Council to receive written reports on the management and outcomes of the adoption service every 6 months.
  - (b). It is important that elected members are aware of the work of the Family Placement Panel in order that they can effectively fulfil their responsibilities as Corporate Parents to children looked after.
