BACKGROUND AND EXTERNAL CONSULTATION

- 5. An inspection was carried out by Ofsted Inspectors between 6 and 17 June 2011. The purpose of the inspection was to evaluate the contribution made by relevant services in the local area towards ensuring that children and young people are properly safeguarded and to determine the quality of service provision for looked after children and care leavers.
- 6. The inspection report (Appendix 1) identified areas of strength and areas of practice that met requirements, with some areas for development.
- 7. An Action Plan will be developed to address the areas for development identified within the Ofsted report and brought to a future meeting of Corporate Parenting Board. The Inspection did not identify issues that the Service was not already aware of.

Looked After Children

8. The second part of the inspection report focuses on services and outcomes for looked after children and care leavers. Services were rated as adequate overall, with the support for children leaving care rated as outstanding. The main focus of action plans will be to strengthen the virtual school and a range of work with Looked After Children.

10. The Ofsted report documents the findings from the Ofsted Inspection of safeguarding and looked after children services in Middlesbrough and an action plan is required to address recommendations.
