This home was judged requires improvement to be good at the last full inspection. At this interim inspection the home was `not judged'.

This home closed in February 2019 for refurbishment. The reports of the independent Regulation 44 visitor confirm that no placements have been made since the home closed.

The registered manager explained that the conditions under which the home operates are to change. The provider will make the necessary application for variation of conditions. The registered manager is to move to another home within the local authority. The registration requirements for this move are in progress.

This home will be managed by a registered manager who is currently based in another children's home. The registration requirements for this move are also in progress.

The home is fully staffed. The staff team is undergoing training in preparation for children and young people being placed when the home re-opens. The full training programme will ensure that members of staff have the skills required for the changes that are planned.



The requirements raised at the last inspection will be reviewed by Ofsted when the home re-opens.

Recommendations

- Staff skills for safeguarding should include being able to identify signs that children may be at risk, and support children in strategies to manage and reduce any risks. Staff should encourage children to express their views about whether they feel safe both within and outside the home. Staff should support children to understand how to ask for help to stay safe and that the home is an environment which supports this. ('Guide to the children's homes regulations including the quality standards', page 43, paragraph 9.10)
- Staff need the knowledge and skills to recognise and be alert for any signs that might indicate a child is in any way at risk of harm. The registered person should ensure that skills in safeguarding are gained, refreshed and recorded in the home's workforce plan. ('Guide to the children's homes regulations including the quality standards', page 43, paragraph 9.12)

In particular, the registered provider must ensure that all staff, including the registered manager, undertake training on county lines behaviour, delivered by a suitably qualified and experienced practitioner.

Information about this inspection

Inspectors have looked closely at the experiences and progress of children and young people. Inspectors considered the quality of work and the differences made to the lives of children and young people. They watched how professional staff work with children and young people and each other and discussed the effectiveness of help and care provided. Wherever possible, they talked to children and young people and their families. In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is



making for the children and young people whom it is trying to help, protect and look after.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
