PURPOSE OF THE REPORT

1. To provide Council with an update on special urgent and urgent decisions for the period September – November 2015

SPECIAL URGENT DECISIONS

2. A special urgent decision is where the required statutory notice of the proposed decision cannot be given (ie it is not possible to give the five days public notice). A decision is defined as urgent where any delay likely to be caused by the call-in process would seriously prejudice the interests of the Council or the public. In terms of the Scrutiny call-in procedure, agreement that the decision cannot be reasonably deferred is always sought from the Chair of Overview and Scrutiny Board or the relevant Scrutiny Panel. Once this agreement is obtained, public notices are placed at the Town Hall, the Contact Centre and Central Library receptions. The decision taker must sign a form recording the decision and a record of that decision is then e-mailed to all Councillors and forms a public record of that decision. The information is also available on the E-genda system or via the Executive Office.

URGENT DECISIONS

3. An urgent decision is where the required statutory notice of the proposed decision can be given but due to urgent deadlines for implementing those decisions, the Scrutiny call-in procedure do not apply. Agreement is always sought from the Chair of Overview and Scrutiny Board or relevant Scrutiny Panel to exempt the proposed decision from the call-in process. The decision then becomes a public record. The information is also available on the E-genda system or via the Executive Office.

Reason for Urgency	The Council has evidence to suggest the owners of The Crown are potentially seeking to demolish the building, which would result in the loss of a valuable local heritage asset. The confirmation of the Article 4 Direction as a matter of urgency could be critical as the immediate Direction expires on 7th November 2015
