15/83 COUNCIL GOVERNANCE AND SENIOR MANAGEMENT ARRANGEMENTS, INCLUDING THE ROLES OF SECTION 151 AND MONITORING OFFICERS -REPORT OF THE CHIEF EXECUTIVE
