### SCRUTINY PROGRESS REPORT

### PURPOSE OF THE REPORT

1. To update the position in respect of the Council's Overview and Scrutiny Board (OSB) and scrutiny panels. The current position regarding progress made by the Board and each of the panels is set out below.

### **OVERVIEW AND SCRUTINY BOARD**

2. Since the last Council update, the Overview and Scrutiny Board met on the following dates:

### Ad Hoc Scrutiny Panel

4. The Panel's Final Report on Apprenticeships was submitted to the Overview and Scrutiny Board on 13 June 2017, where it had been approved for submission to the Executive.

As per the recommendations of the report, a further meeting of the Panel would be scheduled for November 2017 in order for an update to be received.

### Children and Learning Scrutiny Panel

- 5. The scrutiny panel met on 5 April 2017 to continue its investigation of Pupil Exclusions in Middlesbrough. At the meeting the panel received evidence from Middlesbrough's main alternative education providers, for excluded pupils. Representatives from Middlesbrough College, River Tees Multi Academy Trust and Lingfield Farm Choosing Pathways Programme were in attendance. The meeting provided Members with information in respect of each provider's:
  - Aims and objectives.
  - Policies, rules, interventions, rewards and sanctions, which assist in managing behaviour and helping pupils to achieve their full potential.
  - Achievements.

The scrutiny panel's last meeting was held on 14 June 2017. At the meeting the scrutiny panel considered its work programme and identified the following two topics it would like to investigate in 2017/18:

- Listening to the voice of the child
- Emotional wellbeing and mental health of children and young people

The above topics are subject to approval by the Overview and Scrutiny Board.

# Community Safety and Leisure Scrutiny Panel (now Culture and Communities Scrutiny Panel)

6. The first meeting of the Culture and Communities Scrutiny Panel is scheduled to take place on 17 July 2017.

# Economic Regeneration and Transport Scrutiny Panel (now Economic Development and Infrastructure Scrutiny Panel)

7. No meetings of the Panel had taken place since the last update to Council. The next meeting of the Economic Development and Infrastructure Panel would take place on 19 July 2017.

### **Environment Scrutiny Panel**

8. The Panel met on 6 April 2017 and received an update on Bereavement Services. Officers provided an update on the Panel's previous recommendations and other relevant information.

9. The Panel also considered its Draft Final Report in relation to No Ball Games Signs Policy. The subsequent Final Report was submitted to the Overview and Scrutiny Board on 13 June 2017, where it was approved subject to the addition of a recommendation regarding the monitoring of reports of ball game nuisance/anti-social behaviour to ensure that the decision to no longer process requests for no ball games signs did not result in an escalation of anti-social behaviour complaints.

### Health Scrutiny Panel

- 10. The panel met on 28 April 2017 to receive an update on Breast Radiology Services. Unfortunately owing to the scheduling of the General Election, introduction of the Purdah Period and advice issued by NHS England the NHS organisations scheduled to attend declined their invite. The panel requested that an invitation be re-extended to all invitees to attend a future meeting on this topic.
- 11. The Panel also considered its Draft Final Report in relation to Foetal Alcohol Spectrum Disorder (FASD). The subsequent Final Report was submitted to the Overview and Scrutiny Board on 13 June 2017, where it was approved for consideration by the Executive.
- 12. The next meeting of the Health Scrutiny Panel had been scheduled to take place on 25 July 2017 when the panel would host an all Member Seminar on the STP.
