What is the purpose of this report?

1. The purpose of the report is to seek Council agreement to a formal affiliation between Middlesbrough Council and Royal Fleet Auxiliary Wave Knight.

Why does this report require a Member decision?

2. The agreement to a formal affiliation between the Council and Royal Naval Ships is a Council decision.

Report Background

- 3. The Naval Regional Commander for Northern England and the Isle of Man has approached the Elected Mayor to request that a formal affiliation between Middlesbrough Council and RFA Wave Knight be established. Middlesbrough Council previously adopted HMS Jupiter in 1975, and HMS Marlborough in 1993. HMS Marlborough was subsequently granted the Freedom of the Borough in 2000. Both ships have since been decommissioned.
- 4. In 2016, Middlesbrough Council received the Employee Recognition Scheme Silver Award 2016 in appreciation of their ongoing support to the Armed Forces Community. A Civic affiliation like this would complement the Armed Forces Covenant which provides a vital link between Middlesbrough Council and the Armed Forces.
- 5. If agreed a presentation of a certificate to mark the adoption of RFA Wave Knight will be arranged for 7 November 2018.

What decision(s) are being asked for?

6. That Council approves the formal affiliation between Middlesbrough Council and Royal Fleet Auxiliary Wave Knight.

Why is this being recommended?

7. The affiliation is being recommended as the two ships that Middlesbrough Council had previously adopted have both been decommissioned.

Other potential decisions and why these have not been recommended

Picture of RFA Wave Knight





RFA Wave Knight (A389) is a Wave Knight-class fast fleet tanker, launched in 2000 and accepted into service in 2003. She is the second ship to bear this name in RFA service.

The ships are crewed by 72 Royal Fleet Auxiliary personnel and there is also provision for 26 Royal Navy personnel for helicopter and weapons systems operations.

Wave Knight is able to operate in support of amphibious forces, anti-surface and antisubmarine warfare operations and protection of vital sea areas and shipping.
