The Operators Licence is issued subject to mandatory Licence Conditions and Codes of Practice (LCCP) covering, amongst other

				<p>matters, Social Responsibility, Responsible Gambling, Self Exclusion and Customer Interaction.</p> <p>The LCCP make it a requirement that all Betting and Gambling Premises Operators have comprehensive Policies and Procedures promoting socially responsible gambling covering the above areas. These are subject to regular compliance checks by Gambling Commission Compliance Officers. These procedures and policies cover what action should be taken by staff when they identify those at risk of harm from gambling.</p> <p>In addition, all Operators make an annual financial contribution to organisations for research into prevention and treatment of gambling related harm, to develop prevention approaches and to fund treatment to those harmed by gambling.</p>
