OVERVIEW AND SCRUTINY BOARD

Since the last Council update, the Overview and Scrutiny Board met on 16 July 2019 and appointed Councillor Janet Thompson as Chair and Councillor Matthew Storey as Vice Chair. The Board considered the following:-

Adult Social Care and Services Scrutiny Panel

Economic Development, Environment and Infrastructure Scrutiny Panel

The Panel met on 17 July 2019 to discuss items for the Work Programme for 2019-2020. The Director of Environment and Commercial Services and the Director of Regeneration were in attendance at the meeting and provided additional information as requested by Panel Members. The Panel agreed three reviews in relation to: Infrastructure Delivery, Recycling and Waste Management/Waste Disposal Facility and Teesside Crematorium as well as several updates on previous topics. Following the meeting, details of the items were forwarded to the Overview and Scrutiny Board for approval. The next meeting will take place on 4 September 2019.

Health Scrutiny Panel

The Panel met on 11 June 2019 and appointed Councillor McTigue as Chair of the Panel, and Councillor Coupe as Vice Chair.

Edward Kunonga, Director of Public Health South Tees and Erik Scollay, Director of Adult Social Care and Health Integration attended the meeting to provide an overview of current/future service priorities and suggestions as to where scrutiny could have an impact, add value or contribute to policy development/review.

The Panel met on 9 July 2019 to receive an update from Tees, Esk and Wear Valleys (TEWV) NHS Foundation Trust in respect of the action taken by the CQC to protect the safety and welfare of residents at West Lane.

At that meeting a formal response had also been provided by STCCG in respect of the panel's decision to refer Breast Radiology Diagnostic Services in South Tees to the Secretary of State for Health. STCCG representatives were in attendance to discuss their plans and timescales to undertake a formal consultation with the panel. However, the panel was disappointed to learn that although a timescale had been provided for the commencement of public engagement on this issue. No timescale could at this time be provided in respect of a formal consultation.

An update on regional health issues as raised at the DDTHRW STP Joint Committee meeting, as held in Durham on 12 June 2019 was provided. Members discussed and agreed suggestions for the health scrutiny work programme and these will be put forward to OSB for approval on 3 September 2019.
