- 3. The current Corporate Procurement Strategy ends in 2020 and due to the uncertainty about the impact from both Brexit (potential 'no deal') and COVID 19 it was felt that a refresh would be more appropriate than a full re-design.
- 4. It is intended that the full re-design be completed during 2021/22 with a brand new Corporate Procurement Strategy becoming live in 2023.
- 5. The re-design will not only mean the strategy will look different but the content will also be strengthened including areas such as social value, sustainability and digital advancements.
- 6. This will also allow sufficient time to understand the true impact of COVID and an opportunities that may arise from Brexit, as well as being able to undertake robust consultation with suppliers and the commercial market.
