Purpose of the report	To provide the directorate response to the Social Care and Adult Services Scrutiny Panel's final report on Aster Care Home (Formerly Belle Vue Care Home).	
Summary of the report	The Social Care and Adult Services Scrutiny Panel had concerns about the Belle Vue Care Home following its meeting of 16 November 2016. In response to a Care Quality Commission the Panel decided to establish a working party of the SCASSP with a remit to visit the home and to report back to the full Panel. The working party carried out the visit on 15 September 2017 and were assured from discussions with Council officers and Managers of the home that the care home (now called Aster Care Home) was safe, that management was appropriate and that staff and their families were satisfied with the care and/or treatment that they were receiving. The attached action plan reflects the implementation of on-going arrangements to provide quarterly safeguarding information at the request of the Panel.

# What is the purpose of this report?

1. To provide the directorate response to the Social Care and Adult Services Scrutiny Panel's final report on Aster Care Home (Formerly Belle Vue Care Home).

# Why is this report necessary?

2. The report is necessary as the Social Care and Adult Services Scrutiny Panel (SCASSP) had concerns about the Belle Vue Care Home following its meeting of 16 November 2016. In response to a Care Quality Commission (CQC) report dated 5 May 2017, which was discussed by the Panel on 24 July 2017, the Panel decided to establish a working party of the SCASSP with a remit to visit the home and to report back to the full Panel. The working party carried out the visit on 15 September 2017 and were assured from discussions with Council officers and Managers of the home that the care home (now called Aster Care Home) was safe, that management was appropriate and that staff and their families were satisfied with the care and/or treatment that they were receiving. The attached action plan reflects the implementation of on-going arrangements to provide quarterly safeguarding information at the request of the Panel.

### What decision(s) are being asked for?

3. That Executive approves the attached action plan. The plan recommends the quarterly provision to the SCASSP of information relating to Council decisions to suspend placements in individual care homes and occasions requiring the implementation of the Tees Safeguarding Adults Board's Serious Concerns Protocol.

## Why is this being recommended?

- 4. The proposed action plan is appropriate as it provides the SCASSP with an increased level of information awareness of adult safeguarding activity that has been on-going within the Council; this will support the Panel in its investigations and in shaping the nature of future scrutiny topics.
- 5. No stakeholder consultation was required.

# Other potential decisions and why these have not been recommended

6. No alternative decisions were considered as the recommendation by the SCASSP was straightforward to implement and there were no resource implications.

# Impact of recommended decision

7. Implementation of the recommendation will support the Panel in its investigations and in shaping the nature of future scrutiny topics; this should in turn contribute to improvements in the prevention of, and response to, the abuse of vulnerable adults.
