What is the purpose of this report?

1. To provide the directorate response to the Social Care and Adult Services Scrutiny Panel's final report on Reducing Loneliness and/or Isolation in Later Life.

Why is this report necessary?

2. Loneliness and/or social isolation are exceedingly complex, yet nationally pertinent, issues that can impact upon any person at any point in their lifetime; loneliness is not discriminative (Jo Cox Commission on Loneliness, 2017). In order to ascertain the Local Authority's current position regarding loneliness and social isolation and to explore these issues further, the Social Care and Adult Services Scrutiny Panel held meetings on 20 September 2017, 23 October 2017, 13 November 2017, 20 December 2017, 17 January 2018 and 12 February 2018.

What decision(s) are being asked for?

3. That Executive approves the attached action plan and the responses contained therein.

Why is this being recommended?

- 4. The proposed action plan is appropriate as it will contribute to the reduction of loneliness and/or isolation amongst older adults across Middlesbrough. Additionally, the recommended will contribute to the awareness of issues related to loneliness and/or isolation through improved awareness training for our staff.
