What is the purpose of this report?

- 1. The purpose of this report is to note the contents of the Culture and Communities Scrutiny Panel report on the Selective Landlord Licensing Scheme and approve the attached action plan in response to their findings.
- 2. Key findings from the report are:
 - a. The panel are complimentary of the SLL model in North Ormesby and want to see this model being used in future schemes across the Borough.
 - b. The panel would like to see the North Ormesby model extended for another 5 years (subject to meeting the criteria for SLL and following appropriate consultation) and they would like to see a full evaluation of the scheme in 2020
 - c. The panel would like to see a voluntary accreditation scheme developed for Middlesbrough landlords to be rolled out town wide. This is currently not possible due to financial implications as the SLL team are only funded to deliver the SLL scheme. (this is funded via license fees)
 - d. The panel recommend that any future scheme allocates sufficient funding to employ additional staff to fulfil the housing inspection programme. This has been accounted for in the report re the Newport scheme

Why is this report necessary?

 Overview and Scrutiny Board (OSB) reviewed progress of the North Ormesby Selective Landlord Licensing scheme and the recommendations of the scrutiny panel now need to be considered by the Executive.
