# What is the purpose of this report?

1. To provide the service response to the Economic Development, Environment and Infrastructure Panel's report on Housing Delivery Vehicles (HDVs).

# Why does this report require a Member decision?

2. In line with the Council's constitution, following approval of the Economic Development, Environment and Infrastructure Panel's Scrutiny Report on Housing Delivery Vehicles (HDVs) by Overview and Scrutiny Board (OSB) on 2<sup>nd</sup> October 2018, the recommendations of the Scrutiny Panel now need to be considered by the Executive. If the Executive does not consider the issue within eight weeks of the date of OSB, the matter may be referred to Council.

# What decision(s) are being asked for?

- 3. It is recommended that Executive:
  - a) notes the content of the Economic Development, Environment and Infrastructure Panel's Scrutiny Report on Housing Delivery Vehicles (HDVs); and,
  - b) approves the attached action plan developed in response to the Scrutiny Panel's recommendations.

# Why is this being recommended?

4. It is a requirement that Executive formally considers the Scrutiny Panel's report and confirms the Service Area's response to the Panel's accompanying action plan.

#### Other potential decisions and why these have not been recommended

5. Full details of what the Scrutiny Panel took into consideration when arriving at their recommendations are contained in the Scrutiny report (Appendix 1).

# Impact(s) of recommended decision(s)

- 6. The impacts of the recommended decision(s) are to:
  - a) ensure the benefits and challenges associated with different models of HDVs are considered:
  - b) identify the initial resources needed to set up a HDV as well as the potential financial returns; and,
  - c) understand how the project increase in population and the need for a further 5,500 dwellings by 2029 can be met;
  - d) ensure that the requisite associated infrastructure for new housing development including roads, schools, services and green spaces can be delivered in conjunction with a HDV.

#### Legal

7. Legal and Democratic Services will be consulted throughout the implementation of the Scrutiny action plan. The governance issues inherent in any new model of delivery will be a major focus and detailed legal expertise will be required.

#### **Financial**

8. The Scrutiny Panel's report and action plan have highlighted that there will be an initial capital requirement to establish the HDV. A detailed financial business plan will be developed for the HDV, in consultation with Financial Planning and Support, as part of the formal approval process.

9. No Policy Framework implications have been identified.

# **Equality and Diversity**

 Equality and diversity issues would be considered as part of the formal approval process to establish a Housing Delivery Vehicle. This would include Impact Assessments where required.

#### Risk

- 11. The following risks, which have been identified in the Strategic and Directorate Risk Registers, will be reduced by the recommended decisions:
  - O1-005 If poor economic growth occurs, then this will reduce public and private sector investment in the town, including town centre retail, housing development and business.
  - O1-004 If the New Homes Bonus funding is reduced, due to a change in the funding regime or the Council failing to build new homes at the targeted rate then Council Tax receipts will not be maximised, impacting upon the Council's MTFP.
  - O1-045 If delivery of the new housing programme does not meet the projected targets then this can have a negative impact on the assumptions within the MTFP.

#### Actions to be taken to implement the decision(s)

12. The proposed actions in response to the Scrutiny Panel's recommendations are detailed in the Action Plan (Appendix 2).
