2. At the last meeting of the Overview and Scrutiny Board, the following matters were discussed and considered necessary to feed back to the Panel.

Executive Feedback – 8 and 22 February 2005	The Board was presented with, and accepted the decisions of the Executive in relation to the final reports of the Allotment Service Provision, the Active Middlesbrough Strategy and the Local Transport Plan.
2004/2005 Third Quarter Revenue Budget Outturn	This report was presented to the Board for consideration and agreement of its contents and virements. The Board asked and received clarification on numerous items including the social care fund, the Housing Revenue Budget and exclusion figures.
2004/2005 Third Quarter Capital	The Board considered and agreed the report
Budget Outturn	and its appendices.
Community Strategy	The Board agreed the final paper and its

	revised contents. The Chair thanked the Panels for their contribution into this paper.
Corporate Performance Plan 2005/06	After presentation of the report the Chair requested that it be presented to each of the individual Panels, for their comments. It was decided that the most appropriate meeting would be the last meeting in April, before feeding back into the OSB.
Communications Strategy	The Panel was consulted on the Communications Strategy.
Healthy Living Review	The Chair of the Health Scrutiny Panel presented the final report into the Healthy Living Initiatives. The Report and its recommendations were agreed. A number of questions were raised and it was also decided that the Council AGM might not be the correct forum for this report to be presented. As per recommendation j) the Chair of the OSB requested that 'evaluation frameworks' be extended to other initiatives.
Scrutiny Review – Implementation of Recommendations	The Panel considered the information presented in the report and appendices. The Panel requested that a progress report of the recommendations that have been and not been implemented be represented to the to the Executive. It was agreed that the OSB received feedback into the implementation of recommendations.
Request for Scrutiny Review from Non-Executive Member	The Panel considered a report into the provision of an 'Off Road' facility. The Panel agreed to consider this review for the 2005/06 Scrutiny Programme, prior to being presented to CMT and the Executive Member.
Any other business:	The Panel Chair and Vice-Chairs presented their Panel updates to the OSB. One Panel Chair requested clarification on the possibility of extending the timetable due to the emerging importance of the review. It was accepted that Panels could extend their timetables if necessary.
