Respite and Palliative Care Services	The briefing paper was produced in response to the recommendations of the Middlesbrough and Eston Health Scrutiny Joint Committee following its review of 'Respite and Palliative Services for Children with Life Limiting Illnesses'.
	The Board were in agreement that an event should be arranged for all Members across the Tees Valley. The event will encourage Members to discuss the types of services required to address the support needs of children with disability and complex health needs across South Tees, and further consider the extent to which these services can be developed. The Board requested that representatives from the NHS Trust and Middlesbrough PCT be invited to attend this event.
	The Board agreed that attempts will be made to ensure that Government Members fully appreciate the urgency of publishing both the eligibility criteria guidance for assessing continuing healthcare funding, and clarification regarding the legality of using health funding for individualised budgets.
