Health Scrutiny Panel Final Report – Life Expectancy in Middlesbrough with a particular focus on Cardiovascular Disease	The Health Scrutiny Panel investigated one of those diseases faced by society, cardiovascular disease (CVD), which the Panel discovered poses significant problems for Middlesbrough. The Panel established the present rates of CVD in Middlesbrough, how it compares nationally, the type of services presently available and what could be improved in tackling CVD in Middlesbrough. The Panel also investigated some of the wider societal issues, which seem to play a part in the prevalence in CVD. The report was approved and will be referred to the Executive.
Executive Forward Work Programme	The purpose of the report was to provide the opportunity for the Overview and Scrutiny Board (OSB) to consider whether any item within the attached Executive's Forward Work Programme should be considered by the Board or referred to a particular Scrutiny Panel.
