It was agreed that a further update will be presented to the Board in due course and information will be sought to explain the various reasons for the £770,288 saving on placements for Looked After Children. The Board noted the content of the report.
Open Plan Estates – Final Report of the Economic Regeneration and Transport Scrutiny Panel	The overall aim of the scrutiny investigation was to consider the relevance and the appropriateness of the Council's current open plan policy. The report and its recommendations were approved and will be referred to the Executive.
Health Scrutiny Panel – Final Report – Car Parking at James Cook University Hospital – Response from the South Tees Hospitals Trust	The purpose of the report was to inform the Board of the detailed response from the South Tees Hospitals NHS Foundation Trust, relating to the Health Scrutiny Panel's report into Car Parking at James Cook University Hospital. The Chair made a request that clarification be sought regarding the funding for the introduction of a residents' car parking scheme in Beechwood. The content of the report was noted.
Consideration of Requests for Scrutiny Reviews	The purpose of the report was to inform the Board of the proposed scrutiny review requested from an Executive Director. The Board considered the appropriateness of commissioning a scrutiny review into the topic of breaches relating to the Blue Badge Scheme. The Board agreed that the topic would be incorporated into the work programme for the Social Care & Adult Services Scrutiny Panel.
