BACKGROUND AND EXTERNAL CONSULTATION

- 5. Appendix 1 shows the revenue expenditure to the 31st March 2012. There was an under-spend on the staffing budget due to staff vacancies within the Archives Service. The budget under-spend was reflected in the quarter four invoices to each authority.
- 6. The commitment that was given to achieve an in year saving, prior to the review, of 10%, was achieved.
- 7. Appendix 2 indicates the proposed budget for 2012-2013 and reflects the changes made following the Archives service review undertaken in 2011-12. The contributions from each authority reflect the population based on the mid year estimates for 2010.
