#### **BACKGROUND AND EXTERNAL CONSULTATION**

- 5. Following discussions at the JAC meeting of 26<sup>th</sup> April 2012 and the period of consultation following this, which ended on the 31<sup>st</sup> May 2012, Appendix 1 is the resulting revised proposal for the SLA and Appendix 2 the revised terms of reference for the JAC.
- 6. The main alterations to the SLA and terms of reference are as follows:-
  - The JAC would meet only once per year in February to agree the budget, but provision is made for meetings to be called at other times.
  - Each Council must appoint at least one deputy and nominate up to three persons whom may act as a deputy.
  - Any three members of the JAC shall form a quorum.
- 7. Although it is proposed that the JAC will only meet formally once per year, the Officers for the Library Services in each authority will meet on a regular basis during the year to discuss progress and development of Teesside Archives.
- 8. If the revised SLA and terms of reference are approved, these changes would take immediate effect.
