1 PURPOSE OF THE REPORT			

1.1. The purpose of this report is to present to the Live Well South Tees Health and Wellbeing Board with an update on the progress the Health and Wellbeing Executive has made to exploring opportunities for integrated delivery, commissioning and intelligence. The report also includes a summary of the recently published NHS Long Term Plan and considers how this will impact locally.

2 BACKGROUND

- 2.1 At its meeting in October, the Live Well South Tees Health and Wellbeing Board received a presentation from the South Tees Health and Wellbeing Executive exploring further opportunities for integrated delivery, commissioning and intelligence.
- **2.2** The Live Well South Tees H&WBB agreed
 - a collective willingness to work together that ensures there is a difference to people's lives, is place based to impact on our communities and raise expectations of local people
 - The development of a Health and Social Care System Integration Programme with three key strands delivery, commissioning and intelligence.
- **2.3** The South Tees Health and Wellbeing Executive were tasked with:
 - Defining a clear local vision and scope for integration delivery and commissioning
 - · Considering options for future delivery models
 - Bringing forward options for a future commissioning models
 - Reviewing existing governance arrangements and make recommendations for the future
 - Preparing a Road map for implementation
 - Developing an Integrated Data Set
 - Learning from other systems including Manchester, Durham and Northumberland



- The mandate from the Live Well South Tees H&WBB will help to support new ways of working and facilitate the implementation of integrated commissioning and delivery teams in line with the place based model of care. In order to progress this work there has been a number of discussion at the South Tees Health and Wellbeing Executive to explore how:
 - a placed based model of integration can be developed across South Tees
 - integrated commissioning across health and social care can benefit out local populations well exploring what o can develop a model around place based integration.
- A multi-agency workshop is being held, 29 January, to further plan what this this will look like in detail and identify what actions are needed to take it forward.
- 2.6 To support us in delivering our ambitions an application has been made to NHSE's Aspirant ICS Programme for funding (£150k)to provide the capacity to progress at pace and will give the opportunity and flexibility to identify and remove areas of duplication and inefficiency, contributing to system wide efficiency gains as required within the NHS Long Term Plan.

3 NHS LONG TERM PLAN

- In January 2019, the NHS published its Long Term Plan which takes funding, staffing, increasing inequalities and pressures from a growing and ageing population as its starting point. A summary of the key points within the Long Term Plan is set out in appendix 1.
- 3.2 South Tees Health and Wellbeing Executive have used the Long term Plan to help to shape the proposals for integrated delivery, commissioning and intelligence. Specifically
 - Drive towards integrated care and population health -with key responsibilities placed on primary care
 - Workforce
 - Focus on prevention and tackling health inequalities
 - support local approaches to blending health and social care budgets
