**What is the purpose of this report?**

That members note the outturn for the 2017-18 budget and approve the proposed budget

for 2018-19. The outturn for the 2017-18 budget shows that the service will break even and that it has exceeded its income target as well as securing a small amount of grant funding. Some improvements have been made to the public areas and a new piece of equipment has been purchased for Conservation to help remove dust from large volumes. The 2018-19 budget shows an increase to cover staff pay rises and for Middlesbrough Council to recover costs associated with support services. There has been no increase to the rent or to the rates. Any adjustments to the 2017-18 budget will be made to the quarter 1 invoices.

**Why is this report necessary?**

The 2018-19 budget is required to provide the service at a level in line with the requirements to retain the appointment of Place of Deposit as delegated by the National Archives. The withdrawal of the appointment means that the service would not be able to hold deposited public records under section (1) of the Public Records Act 1958.
