#### a) General - all four licensing objectives (b,c,d,e) (please read guidance note 9)

The management and control of the premises is to be the responsibility of the applicant who is the nominated Designated Premises Supervisor.

A Challenge 25 age verification policy, will be adopted to ensure no person under the age of 18 years is sold intoxicating liquor. This policy to be supported by poster signage within the premises

Prior to grant of application, training, provided by an external provider, in sale of alcohol will be undertaken for all members of staff. Refresher training will be followed up at regular intervals of 6 months.

No new member of staff will be involved in the sale of alcohol until completing full induction training and deemed to be competent to carry out that role.

There will be one additional member of staff trained to the Award for Personal licence holder standard.

#### b) The prevention of crime and disorder

A Digital CCTV system supported by 9 internal cameras is installed. Should this application prove successful 2 external cameras covering front of premises we will be provided. (See enclosed plan) The recorded history will cover a period of not less than 31 days.

A member of staff shall be present on the premises at all times they are open to the public who is capable of operating the CCTV system and providing recordings on request.

A Challenge 25 age verification policy shall be in operation to ensure no person under the age of 18 years is sold alcohol. This policy shall be supported by poster signage within the premises and a refusal book will be maintained at or near the point of sale. Any adult who are believed to be purchasing alcohol on behalf of undeage customers will also be refused.

All staff will be fully trained to ensure that no person who is drunk and/or disorderly or appears to be under the age of 25 years is served with alcohol. Such training to be repeated at 6 monthly intervals and a record of training will be maintained.

The applicant and staff will provide a climate of partnership working with all statutory agencies and participate in the promotion of any suggested initiatives to drive down crime and disorder.

Entry to the premises will be refused to any person who is drunk, threatening or violent. Entry may be refused to any person who has been convicted of an offence of drunkeness, violent or threatening behaviour or use of or distribution of illegal substances at a licensed venue.

Any incident of crime and disorder shall be reported to the Police and an Incident book on the premises will be maintained.

#### c) Public safety

#### c) Public safety

There shall be an appropriate number of adequately trained staff on duty to ensure the safe evacuation of customers from the premises in the event of an emergency. Such staff will have been issued with specific duties to ensure the safety of all those on site

All fire escape routes shall be kept unobstructed and will be clearly identifiable.

All fire exit doors shall be capable of being opened in one operation, without the use of any key, card code or similar means.

All fire fighting equipment will be regularly serviced and maintained in good working order and shall be available for immediate use.

All emergency lighting and fire safety signage will be maintained in good order and will not be altered without the approval of the Fire Authority.

#### d) The prevention of public nuisance

The applicant and all staff will monitor the patrons of his establishment, arriving, whilst present and leaving his premises to minimise any likelihood of public nuisance.

Polite customer notices shall be displayed in a prominent position asking for customers to respect the needs of other members of the public especially during early morning and evening periods.

#### e) The protection of children from harm

The applicant and staff are to be trained to monitor all customers to the premises to prevent the supply of alcohol by adults to underage customers

A Challenge 25 age verification policy will be adopted and notices will be displayed in prominent positions to inform customers entering and using the premises of the Policy supported by refusal registers at each point of sale.

When challenged the only acceptable proof of Age documents will be Passport, driving licence and Pass approved cards



In response to your letter requesting more information regarding the communities' objections to the application for a premises licence for the Post Office 119 Crescent Road Middlesbrough TS1 4QS ref MBRO/PRO250/076255 I have provided the additional information below.

Gresham Community Council objects to this application on behalf of residents the grounds of:-

#### The prevention of crime and disorder

Gresham has a high rate of alcohol fuelled anti-social behaviour.

Shops selling alcohol attract gangs of youngsters hanging around outside and this intimidates residents.

There are eight outlets plus two major supermarkets already selling alcohol all within a half mile radius.

#### **Public safety**

Residents (many vulnerable and elderly) should feel safe in doing business in the post office, introducing alcohol sales could change that, some people using these outlets are under the influence of alcohol from very early in the morning.

Money and alcohol do not sit well together.

#### The prevention of public nuisance

Residents have expressed concern about the noise that will be generated from people using the store, this may be from individuals under the influence of alcohol but also, parking is an issue in the area and the possibility of more people travelling to the shop by car will cause a blight on all those living in close proximity to the store due to parking issues, also the noise of car doors slamming and vehicles coming and going from 7am to 10pm.

#### The protection of children from harm

A recent report has identified that nearly 25% of children in Middlesbrough are living in homes where alcohol has a detrimental effect – the provision of alcohol from a new outlet will not support all the agencies to address this issue.

Children and parents buy sweets and newspapers on the school run. There are two schools close to this shop, introducing alcohol could change this, children should not see alcohol being bought at 8.30 in the morning thinking that this is the norm.

I LIVE OFFOSITE THE CRESCENT-ROAD PEST-OFFICE AND AT PRESENT WE ARE ALRENDY SUFFERING FROM ANTI-SOCIAL BEHAVIOUR FROM YOUNG PEOLE DRINKING ALCOHOL, LENVING ALCOHOL BETTLES, CANS LITERED NEAR THE PHONE-BOX AT THE SIDE OF THE POST-OFFICE, AND ALSO BEHAVING ABUSE TO MEMBERS OF THE PUBLIC LIVING NEARBY OR WALKING PAST, GROUPS OF YOUNG PEOPLE HAVE PREVIOUSLY BEEN MOVED EN BY POLICE FOR CAUSING A NUSAINCE, AND CRIMINAL DAMAGE TO ROBERTY. CONGREGGETING NEAR THE POST-OFFICE WITH ALCOHOL BOTTLES, CANS AND I HAD BEEN SWORN AT WHEN I HAVE ASKED THEM NOT TO MAKE TOO MUCH NOISE.



The premise is situated in a busy Town Centre street which is a densely populated housing estate, with residents living in close proximity to the premises. The street in which the building is located currently has thirteen other licensed premises in the vicinity which deal in off sales of alcohol. These premises are highlighted in red. 119 Crescent Road is highlighted in black on the map (attached). I exhibit the map containing these premises as JKB/1.

From 01/01/2012 – 25/07/2012 statistics show that there have been 41 incidents of anti social behaviour in the area bordered by and including Ayresome Street, Haywood Street, Parliament Road and Linthorpe Road 11 of which are alcohol related. The key times for anti social behaviour in this area are between 1100 hours – 1159 hours and 1800 hours – 2359 hours. I exhibit these statistics as JKB/2.

The 11 incidents of alcohol related anti social behaviour occur at various locations in the residential areas surrounding the location of the premises. I exhibit these incidents as JKB/3.

Although there have been 11 incidents of alcohol related anti social behaviour there have been 30 incidents of disorder, anti social behaviour and general nuisance. These incidents are not specified as being alcohol related however this is due to the way in which incidents are recorded based on the complainant's initial report. As a consequence I am unable to determine whether alcohol was the primary cause of each of these incidents. I exhibit these incidents as JKB/4.




The following analysis is based on all anti-social behaviour related incidents that have occurred within a bordered area (Ayresome Street, Linthorpe Road, Parliament Road and Heywood Street) of Gresham that have occurred between 01/01/2012 and 25/07/2012 at the request of PC1969 BRYAN.

In the bordered area between 01/01/2012 and 25/07/2012 there have been 41 incidents of anti-social behaviour. 11 of the incidents (13%) were alcohol related. Key streets for the alcohol related incidents tend to be Parliament Road (4) and around the area of Carlow Street / Crescent Road / Costa Street (7).

The key streets for all reports of anti-social behaviour in the bordered area are: Parliament Road (4), Crescent Road (4), Costa Street (2), Laycock Street (4) and Linthorpe Road (3).

Other repeat streets are: Carlow Street (2), Harford Street (2), Orwell Street (1), Kildare Street (2), Leinster Road (1), Leven Street (1), Meath Street (1), Wicklow Street (1), Longford Street (1) and Warwick Street (1).

The key times for anti-social behaviour in the bordered area are between 11:00 – 11:59 hours and between 18:00 and 23:59 hours, with a notable peak between 18:00 and 20:59 hours.



As a Police Community Support Officer for the 'Gresham area I deal with alcohol related incidents of anti social behaviour on a weekly basis some of a nature where alcohol is confiscated from persons drinking within the alcohol exclusion zone and direction to leave notices are issued and others were violence has been fuelled by alcohol including a serious incident where by a male had received several stab wounds to his chest, this incident clearly identified alcohol as a factor.

I have in the past received concerns and intelligence to suggest that some licensed premises within the Gresham ward are selling alcohol to underage young people which causes alarm to residents. I feel Gresham have more than enough licensed premises including four public houses and introducing another licensed premise would only allow for further problems. The majority of Crescent Road consists of residential houses but there is also a school on Crescent Road along with three other off licences.

I have spoken to several residents who indicate that they would be against another licensed premise and also feel that the current licensed premises are more than sufficient. Residents speak of their concerns stating persons drinking alcohol in a public place makes them feel vulnerable and very intimidated which has a detrimental effect on their community.
