This is an application to vary a premises licence currently selling alcohol Monday to Sunday 06:00 - 23:00 hours to 00.00 – 24.00 (24 hours daily) and the provision of late night refreshments Monday to Sunday from 23:00 - 00:00 hours to 23.00 – 05.00 hours. In addition to this, additional conditions have been proposed. Cleveland Police make representations for the following reasons:

The premises is situated in area which already suffers from anti social behaviour and crime and disorder. Indeed, in a six month period, there were numerous incidents of anti social behaviour of which, a large proportion were alcohol related and disorder in the vicinity surrounding the premises.

In addition to this, the premises is situated close to residential and recreational areas. It is of concern that should the premises be allowed to sell alcohol 24 hours each day of the week, the problems already encountered will increase, thus undermining the above licensing objectives resulting in a detrimental effect on the lives of nearby residents.

Cleveland Police refer to Middlesbrough Council Licensing Policy Statement, paragraph 7.5 of Public Nuisance which states:

“In predominately residential areas the Licensing Authority will normally expect all licensable activities to cease at 11pm, with the premises to close no later than 11.30pm”.

For the above reasons, Cleveland Police have no alternative but to make representations to this application. Failure to do so will result in undermining the above licensing objectives.

I am a Police Constable with Cleveland Police. I am currently stationed at MIDDLESBROUGH POLICE STATION (M8), BRIDGE STREET WEST, MIDDLESBROUGH attached to the District Licensing Unit (DLU).

My role as a Licensing Officer involves dealing with licensed premises which include on/off alcohol sales and late night refreshment venues. I carry out regular enforcement visits at all licensed premises. This is to ensure that premises are run correctly, the conditions of the licence are being adhered to and the licensing objectives are being promoted.

In October 2012, Cleveland Police received an application to extend the hours for the sale of alcohol at this premises to 24 hours daily. Cleveland Police made representations to the application on the grounds that, if granted, this would undermine the licensing objectives. However, an agreement was reached with the applicant whereby the hours for the sale of alcohol were varied from 08.00 – 23.00 Monday to Saturday and from Sunday 10.00 – 22.30 to 06.00 – 23.00 hours daily.


Cleveland Police have again received an application to vary the premises licence to allow the sale of alcohol 24 hours a day Monday to Sunday. An application has also been made to provide late night refreshment between 00:00 hours – 05:00 hours Monday to Sunday.

This application is yet again of concern to Cleveland Police since the premises is situated on a busy crossroad in Middlesbrough. It is on the edge of a densely populated housing estate, and is in close proximity to several recreational areas where anti social behaviour and alcohol related incidents are already an issue.

It should be noted that from 01/04/2013 – 14/10/2013 there has been 15 alcohol related incidents. I exhibit these as JKB/1. In addition to these incidents, there have been numerous incidents of disorder, anti-social behaviour and general nuisance. These incidents are not specified as being alcohol related. However, this may be due to the way in which incidents are recorded, based on the complainant's initial report. I exhibit these incidents as JKB/2. The area where these incidents have occurred is bordered by Stewarts Park, Prissick Base, the open area at the rear of JCU hospital and a residential area. I exhibit a map of this area as JKB/3.

The key times for anti social behaviour in this area are between 18:00 hours – 23:59 hours. A number of anti social behaviour incidents have occurred at licensed premises that are situated within the vicinity.






