Representations are being made for the following reasons:

An Enforcement visit was conducted on 22/09/2017 at Kilimandjaro Restaurant, Unit 3 Navigation Point, Hartlepool marina, Hartlepool, TS24 0UG and an illegal worker was encountered.

The Enforcement visit was conducted at the BUSINESS premises to locate persons suspected of being illegally present and working in the United Kingdom.

Entry gained at 17.42.

The purpose of the visit was explained to the male member of staff behind the counter bar and staff entered under section 179 of the licensing act 2003. Two further males were encountered at the rear of the premises in the kitchen area both wearing Kilimanjaro t-shirts and black trousers.

A chef was questioned who claimed to have only started on the day and was training, checks with the office confirmed he had been granted Asylum until 2020.

Further checks were conducted with the other male encountered, checks confirmed he had no leave to remain.

The owner APOLLO entered the building following a call from one of the staff. employer questions with owner APOLLO, he answered a couple of questions then refused and refused to sign notebook. APOLLO became quite agitated claiming we were stopping his customers from entering. The Immigration Officer advised they were not stopping anyone from entering.

It appears that he is now opening a Kilimandjaro Restaurant in Middlesborough and we believe he will not comply with licensing objectives.
