APPLICATION TO REVIEW PREMISES LICENCE

Applicant: Environmental Health, Middlesbrough Council **Ref.No.** OL/15/8

Premises: The Zetland Public House, Zetland Road St Hildas Middlesbrough TS1 1EH

Application received: 15 April 2015

Summary of Current Licensable Activities:

Supply of alcohol on and off premises – 10.00am to 2.30am Monday to Sunday
Other regulated entertainment – 10.00am to 3.00am Monday to Sunday

Full details of the application for review is attached at Appendix 1. A copy of the current Premises Licence is attached at Appendix 2.

1. Notification to Responsible Authorities:

The Environmental Health Officer confirmed that copies of the application to review the premises licence were submitted to all responsible authorities and the premises licence holder on 15 April 2015.

2. Notice of Application: A notice giving details of the application was displayed adjacent to the premises by a Licensing Officer on 15 April 2015.

3. Legislation

The Licensing Act 2003 requires the Licensing Authority to carry out its functions with a view to promoting the four licensing objectives:

- The Prevention of Crime and Disorder
- Public Safety
- The Prevention of Public Nuisance
- The Protection of Children from Harm

The Licensing Authority must also have regard to its Licensing Policy and any guidance issued by the Secretary of State.

4. Background

The premises consist of a public house located in the central area of Middlesbrough. The premises have been trading with the benefit of a premises licence since the introduction of the Licensing Act 2003 on 24 November 2005. Prior to that date the premises traded with the benefit of a Justices Licence and Public Entertainment Licence. On 11 January 2006 the operating

hours of the premises were changed to those currently in operation by means of a variation to the Premises Licence.

5. The Representations

On 12 May 2015 a representation was received from Cleveland Police supporting the application for a review of the Premises Licence on the grounds of the prevention of crime and disorder and public safety. A copy of this representation is attached at Appendix 3.

2. Exclude a licensable activity from the scope of the licence.
3. Remove the designated premises supervisor.
4. Suspend the licence for a period not exceeding 3 months
5. Revoke the licence.

Members are reminded that any aggrieved party (i.e. Applicant, Responsible Authority, Other Person) may appeal any decision of the Licensing Committee to the Magistrates' Court.
