3. Legislation

The Licensing Act 2003 requires the Licensing Authority to carry out its functions with a view to promoting the four licensing objectives:

- The Prevention of Crime and Disorder
- Public Safety
- The Prevention of Public Nuisance
- The Protection of Children from Harm

The Licensing Authority must also have regard to its Licensing Policy and any guidance issued by the Secretary of State.

4. Background

The premises consist of an established public house with substantial food trade, trading without a Public Entertainment Licence. The premises previously held a Justices 'On' Licence and a Children's Certificate issued pursuant to the Licensing Act 1964. These licences have been converted to a Premises Licence as part of this application.

5. The Representations

On 25 May 2005 a representation was received from Cleveland Police (see Appendix 2).

Following a meeting between the Applicant, his legal representative and representatives from Cleveland Police agreement was reached regarding all points raised in the representation with the exception of point 3. The Applicant has subsequently amended his application to reflect this (see Appendix 3). Therefore the matter listed at point 3 (of Appendix 2) requires consideration by Members.

On 7 June 2005 a representation was received from Coulby Newham Community Council which objects to the proposed increase in hours on the grounds of anti social behaviour and disturbance to local residents, in particular residents of nearby residential homes for the elderly (see Appendix 4).

On 8 June 2005 a representation was received from Councillor P Thompson acting as a local resident himself and on behalf of 3 other local residents. In summary Councillor Thompson objects to the increase in hours citing issues of anti social behaviour (see Appendix 5).

On 6 June 2005 a representation was received from Paul MacGregor, Principal Environmental Health Officer which objected to the application to vary the licence on the grounds of noise disturbance (see Appendix 6).

Following a meeting between the Applicant, his legal representative and representatives from Environmental Protection Noise Team Police agreement was reached regarding all points raised in the representation with the exception of point 6 and 7. The Applicant has subsequently amended his application to reflect this (see Appendix 3). Therefore only those matters listed at point 6 and 7 (of Appendix 6) requires consideration by Members.
