3. Legislation

The Licensing Act 2003 requires the Licensing Authority to carry out its functions with a view to promoting the four licensing objectives:

- Public Safety
- The Prevention of Public Nuisance
- The Protection of Children from Harm

The Licensing Authority must also have regard to its Licensing Policy and any guidance issued by the Secretary of State.

4. Background

The premises consist of a Shop with Ground floor cafe trading with the benefit of a Justices 'On' Licence. This licence has been converted to a Premises Licence as part of this application.

5. The Representations

On 22 July 2005 a representation was received from Cleveland Police which objects to the application to vary the premises licence on the grounds of the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm. (see Appendix 2).

On 24 June 2005 a representation was received from Portman Street residents Association, which objects to the application to vary the premises licence on the grounds of public nuisance.(see Appendix 3).
