- 3. Background Information

The premises consist of the ground floor of a building situated in a parade of shops on Stokesley Road, a busy shopping area in a residential area of the town.

4. The Representations

The Gambling Act 2005 allows Responsible Authorities and Interested Parties to make representations in respect of applications for premises licences. The Responsible Authorities are listed in paragraph 1 in this report. There have been no objections from the Responsible Authorities in relation to this application.

An Interested Party is defined in the Act as a person who: -

- a) lives sufficiently close to the premises to be likely to be affected by the authorised activities,
- b) has business interests that might be affected by the authorised activities, or
- c) represents persons who satisfy (a) or (b).

Representations must also be relevant to the application. The Gambling Commission guidance states representations are likely to be relevant if they relate to the licensing objectives or raise issues under the Council's Statement of Principles, the Gambling Commission's Guidance or Codes of Practice. Expected demand for the facilities which the premises propose to provide is not a relevant consideration.

On 3 April 2012 a representation was received from Dr W D Kean, a local resident (Appendix 2). The representation refers to the licensing objective of protecting children and other vulnerable persons from being harmed or exploited by gambling.

On 3 April 2012 a representation was received from Councillor Dorothy Davison, Ward Councillor for the Marton Ward, on behalf of both herself and Councillor Tom Mawston, the other Councillor for the Marton Ward. (Appendix 3). The representation refers to the licensing objective of protecting children and other vulnerable persons from being harmed or exploited by gambling.

On 3 April 2012 a representation was received from Ann Lesley Rigg, Secretary of Marton Community Council (Appendix 4). The representation refers to the licensing objective of protecting children and other vulnerable persons from harm.

5. Considerations

The considerations the Committee should take into account when deciding whether or not to grant the Application are as follows:

- a. The Committee shall aim to permit the use of premises for gambling in so far as it thinks fit
- b. The application is in accordance with any relevant code of practice issued by the Gambling Commission
- c. The application is in accordance with any relevant guidance issued by the Gambling Commission
- d. The application is reasonably consistent with the licensing objectives, namely:-
 - preventing gambling from being a source of crime and disorder
 - ensuring that gambling is conducted in a fair and open way, and

- protecting children and other vulnerable persons from being harmed or exploited by gambling.
- e. The application is in accordance with Middlesbrough Council's Statement of Principles.

The Committee must not have regard to the expected demand for the facilities which the premises are to provide nor whether or not the proposal is likely to obtain planning permission or building regulation approval.

6. Options

The Committee may grant the application, exclude a default condition or add or amend a condition, or reject the application. The mandatory conditions in relation to this application are contained in Regulation 3 and 14, Part I of Schedule 5 of the Gambling Act 2005 (Mandatory and Default Conditions) (England and Wales) Regulations 2007.

The default condition in relation to this application is contained in Regulation 15, Part II of Schedule 5 of those Regulations, namely, that no facilities for gambling shall be provided on the premises between the hours of 10.00pm on one day and 7.00am the next day.
