Annex 1 - Mandatory conditions

Mandatory conditions in accordance with Section 19 of the Licensing Act 2003:

Where a premises licence authorises the supply of alcohol:

- (i) No supply of alcohol may be made under the premises licence:
- (a) At a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (ii) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Effective from 6 April 2010

- (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activites, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children -
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on -
- (i) the outcome of a race, competition or other event or process, or
- (ii) the likelihood of anything occuring or not occuring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkeness in any favourable manner.
- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

Effective from 1 October 2010

4. (1) The premise licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

5. The responsbile person shall ensure that -

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -

(i) beer or cider: 1/2 pint;

(ii) gin, rum, vodka or whiskey: 25ml or 35ml; and

(iii) still wine in a glass: 125ml; and

(b) customers are made aware of the availability of these measures.

Mandatory conditions in accordance with Section 21 of the Licensing Act 2003:

(1) Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, the licence must include a condition that each such individual must be licensed by the Security Industry Authority.

(2) But nothing in subsection (1) requires such a condition to be

(a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with premises licences authorising plays or films), or

(b) in respect of premises in relation to -

(i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or

(ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).

For the purposes of this section -

(a) 'security activity' means an activity to which paragraph 2(1)(a) of that Schedule applies, and

(b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

PUBLIC ENTERTAINMENT

CLEVELAND COUNTY FIRE BRIGADE STANDARD RECOMMENDATION FOR THE USE AND INSTALLATION OF SMOKE GENERATORS

The use of special effects involving the use of lasers, naked flame, smoke production or any other process creating a risk of fire shall not be allowed without the written consent of the Council.

Smoke Generators

- 1. Smoke generator is only to be used on the stage and smoke will only be produced in short bursts.
- 2. Only a minimal amount of cosmetic smoke is to be allowed and exits must always be maintained clear and visible.
- 3. A purpose built and approved smoke generator must be used.
- 4. Smoke generation must be in fixed position, adequately protected against interference by members of the public and manned by a competent operator.
- 5. The machine must be sited so that it does not cause hazard to surrounding risks, such as curtains or drapes.
- 6. The machine must not obstruct exit routes.
- 7. The machine must be sited and the volume of smoke controlled such that it does not affect the means of escape or obscure exit signs. The amount of smoke in public areas should be limited to the minimum necessary for the desired effect. Actual operation of the smoke generator should be restricted, for example, to 2x5 second bursts in any one hour.
- 8. Fans should be used, where necessary, to direct the smoke/vapour into the desired area, in order to prevent clouding at the point of discharge and possible overspill into other parts of the premises.
- 9. The Licensee shall be required to produce documentary evidence of the non-toxicity, non-flammability, non-asphyxiant content of the smoke vapour produced.

NOTE:

Before the use of a smoke or vapour effect is approved consideration should be given to any automatic fire detection or fire sensor system installed in the premises.

Annex 2 - Conditions consistent with the operating schedule

LICENSING OBJECTIVES

GENERAL - ALL FOUR LICENSING OBJECTIVES

THE PREVENTION OF CRIME AND DISORDER

- The premises must be fitted with internal and external digital, colour, CCTV. All footage must be kept for a minimum of 31 days and kept in a locked and secure cabinet.
- Notices will be displayed throughout the premises notifying patrons that CCTV is in operation 24 hours a day.
- 3. All glasses shall be made of toughened glass.
- 4. There shall be no time led or all inclusive drinks promotions at any time or any other promotion which encourages irresponsible or immoderate drinking.
- 5. An incident book will be used to record all incidents of crime and disorder.
- 6. The premises will have a written drugs policy and an approved drug box and drug register which will be used to dispose of and record all illegal substances found.
- 7. A record of all staff training will be retained by the Premises Licence Holder.
- 8. On any occasion when the premises is open after 8pm on a Friday, Saturday or Sunday a minimum of 2 SIA registered doorstaff will be on duty.
- No glasses/open bottles or other open containers shall be allowed to leave the premises at any time.
- 10. Any person(s) appearing or acting intoxicated or acting in a disorderly manner will be refused entry to the premises. A refusals book will be kept fully updated to show persons refused.
- 11. The Challenge 21 Scheme will be adopted at the venue and only photographic identification (driving licence/ passports/ PASS cards) as proof of age will be accepted.
- The designated premises supervisor or a representative will actively take part in the local pubwatch scheme.
- 13. There shall be a search policy on entry where deemed appropriate.
- 14. Staff will prevent patrons leaving the premises with bottles or any open vessel.
- 15. A metal detector shall be made available at the premises.
- 16. An apex pubwatch radio shall be purchased for use at the venue to stop patrons refused entry from the town centre venues gaining access.
- 17. Entry to the premises after 3am daily shall be restricted to members.
- 18. All members are to be issued with a photographic identification membership card prior to entry.
- 19. A register of members is to include details of the full name, address, date and place of birth of each member.
- All membership cards are to be scanned using 'clubscan' or equivalent software before entry to the premises.

PUBLIC SAFETY

- 1. A risk assessment shall be carried out on the premises
- 2. Electrical safety checks (PAT Testing) to be carried out on electrical equipment.
- 3. Notices are to be displayed in prominent parts of the venue stating entry policy. NO I.D. No ENTRY
- 4. Hand held counting devices will be used to ensure capacity is not exceeded.
- 5. When possible there shall be a fully qualified first aider on the premises
- 6. Staff will be trained in Health and Safety and records of that training shall be kept.
- 7. Nominated taxi firms will be notified well in advance of any event to cater for patrons leaving.
- 8. A taxi free phone shall be installed for patrons to use
- 9. An operating schedule shall be produced
- 10. A company Health and Safety Policy shall be in operation
- 11. All walkways to be checked prior to opening for any trip hazards or spillages
- 12. Procedure for spillages to be in place
- 13. Fire fighting equipment to be inspected daily and logged.
- 14. Emergency exits to be checked prior to opening for any obstructions
- 15. Fire alarm to be tested weekly and logged

- 16. Adequate first aid equipment to be on site at all times
- 17. Accident book to be on site and any accidents logged
- 18. All equipment to be well maintained

THE PREVENTION OF PUBLIC NUISANCE

- 1. There shall be adequate lighting on the exterior of the building
- 2. Outside to be cleaned and swept regularly to keep litter to a minimum
- 3. Notices will be displayed asking patrons to leave the premises quietly
- 4. Patrons who repeatedly leave the premises in a noisy manner will be barred from the venue
- Entertainment noise shall not be audible nor raise the ambient noise levels inside residential premises located on Lees Road, Carey Close or Victoria Street after 11pm
- 6. A double sided 2 metre lobby shall be incorporated in the fire exit on the premises south-western façade.
- All fire exit doors shall incorporate acoustic seals.
- 8. The licensee shall have control of music sound levels at all times, not the DJ or other performers.
- Where practicable entertainment noise shall be played through house amplification system and loudspeakers.
- Entertainment noise shall be controlled via frequency adjustable sound limiters to control sound output at 63Hz and 125Hz mid frequencies, set to operate at levels agreed with the Licensing Authority.
- 11. All bass bins and loudspeakers shall be acoustically isolated from the building structure to prevent flanking caused by structure borne sound transmission.
- 12. Where practicable, the premises shall incorporate downward facing loudspeakers featuring narrow directive patters, in order that sound is directed onto the dance floor only.

PROTECTION OF CHILDREN FROM HARM

- Persons under the age of 18 will not be allowed on the premises unless at a special under 18's
 event
- 2. At an under 18 event the following shall be in place:
- · Fully qualified paramedic on premises
- · Registered SIA security team shall be on duty at all times to assist or answer questions
- · Age limit will be 14 to 17 years of age
- · Identification will be requested
- Only non alcoholic drinks shall be sold or displayed
- If patrons are refused entry then efforts shall be made to contact their parents to ensure they are collected safely
- Anyone found under the influence of drink or drugs will when possible have their parents contacted and asked to collect them.
- · All incidents are to be recorded and when necessary the Police to be informed
- All patrons shall be searched on entry. If patrons refuse to be searched then they will not gain entry into the premises

Annex 3 - Conditions attached after a hearing by the licensing authority

- A double sided 2 metre lobby shall be incorporated in the fire exit on the premises south-western facade.
- 2. All fire exit doors shall incorporate acoustic seals.
