I am a Police Constable with Cleveland Police. I am currently stationed at MIDDLESBROUGH POLICE STATION (M8), BRIDGE STREET WEST, MIDDLESBROUGH attached to the District Licensing Unit (DLU).

My role as a Licensing Officer involves dealing with licensed premises which include on/off alcohol sales and late night refreshment venues. I carry out regular enforcement visits at all licensed premises. This is to ensure that premises are run correctly, the conditions of the licence are being adhered to and the licensing objectives are being promoted.

Coronation Service Station is a petrol station situated on a busy main road in Middlesbrough. Cleveland Police have received an application to allow the sale of alcohol off the premises during 06:00 hours to 23:00 hours Monday to Sunday, and the provision of late night refreshment from 23:00 hours to 05:00 hours Monday to Sunday. The premise has applied to open 24 hours daily however the above hours will apply to licensable activity.


This application is of concern to Cleveland Police as the premise is situated on the edge of a densely populated housing estate, and is in close proximity to areas where anti social behaviour and alcohol related incidents are already an issue. There are three other licensed premises in close proximity to the Service Station that sell alcohol.

There have been very few alcohol related incidents reported close to where the premise is situated within a six month period, however alcohol related incidents rely on the reporting persons knowledge of there being alcohol involved. I exhibit the incidents as JKB/1.

There have been 11 anti social behaviour incidents reported in the last six months in the vicinity of the service station. I exhibit these incidents as JKB/2.

Although there have been incidents of alcohol related anti social behaviour there have been incidents of disorder, anti social behaviour and general nuisance. These incidents are not specified as being alcohol related however this is due to the way in which incidents are recorded based on the complainant's initial report. As a consequence I am unable to determine whether alcohol was the primary cause of each of these incidents.

Within a six month period there have been a number of Theft incidents at the Service Station. This is in relation to vehicles obtaining petrol and failing to pay for the petrol prior to making off from the location. These incidents are not alcohol related however this shows a propensity for Theft at the premise. I exhibit the incidents of Theft as JKB/3.



The area in which the premise is situated has recently been subject of a Dispersal Order in relation to Anti Social Behaviour and Criminal Damage. The dispersal order was in force from 17th October 2014 – 7th November 2014 in the area bounded by, and including Acklam Road, Ladgate Lane, Marton West Beck, Emmerson Avenue and Green Lane. The premise is situated on Acklam Road and on the Boundary of the area dictated in the dispersal order. I exhibit a copy of the dispersal order as JKB/4.

PC Mark Wilkinson has been the ward officer for the Acklam area for a number of years and has an in depth knowledge of the issues in the area. PC Wilkinson has provided a statement to this effect. I exhibit the statement as JKB/5.

Cleveland Police are concerned that the Prevention of Crime and Disorder and the Prevention of Public Nuisance objectives will be undermined as the premises is situated in an area that already suffers from alcohol related disorder, and underage drinking which is closely linked to anti social behaviour. In addition the premises is situated in a residential area and if granted will have a detrimental effect on the lives of nearby residents.
