I am a Police Constable with Cleveland Police. I am currently stationed at MIDDLESBROUGH POLICE STATION (M8), BRIDGE STREET WEST, MIDDLESBROUGH attached to the District Licensing Unit (DLU).

My role as a Licensing Officer involves dealing with licensed premises which include on/off alcohol sales and late night refreshment venues. I carry out regular enforcement visits at all licensed premises. This is to ensure that premises are run correctly, the conditions of the licence are being adhered to and the licensing objectives are being promoted.

Marton Road Service Station is a licensed premises situated on a busy crossroads in Middlesbrough. It is licensed to sell alcohol off the premises during 06:00 hours to 00:00 hours Monday to Sunday, and the provision of late night refreshment from 23:00 hours to 05:00 hours Monday to Sunday. The current premises licence holder is Mr Mohan Palani Samy.

Cleveland Police have received an application to vary the premises licence to allow the sale of alcohol 24 hours a day Monday to Sunday.

This application is of concern to Cleveland Police as the premise is situated on the edge of a densely populated housing estate, and is in close proximity to several recreational areas where anti social behaviour and alcohol related incidents are already an issue.


From 01/07/2014 – 30/06/2015 statistics show that there have been 29 incidents of anti social behaviour in the area bordered by and including The Grove, The Derby, Broadwell Road, the open area at James Cook University Hospital, Prissick Base and Stewarts Park, 20 of which are alcohol related.

A number of anti social behaviour incidents have occurred at licensed premises that are situated within the boundary as detailed above.

The 20 incidents of alcohol related anti social behaviour occur at various locations in the residential areas surrounding the premises. This is an increase of 5 incidents from the previous year. I exhibit these incidents as JKB/1.

- Incident 1: 18/07/2014 at 2226 hours on Marton Avenue, Middlesbrough. Report of 20 youths that are intoxicated and causing criminal damage.




- Incident 20: 10/06/2015 at 1713 hours on Stokesley Road, Middlesbrough. Report of 3 males sitting in the play area drinking. The males have carrier bags with them containing cider.

Although there have been 20 incidents of alcohol related anti social behaviour there have been 29 incidents of disorder, anti social behaviour and general nuisance. These incidents are not specified as being alcohol related however this is due to the way in which incidents are recorded based on the complainant's initial report. As a consequence I am unable to determine whether alcohol was the primary cause of each of these incidents. I exhibit these incidents as JKB/2.

Also included is a map of the boundary area as detailed above, this map shows the area in which the incidents referred to have occurred. I exhibit the map as JKB/3

Cleveland Police are concerned that the Prevention of Crime and Disorder and the Prevention of Public Nuisance objectives will be undermined as the premises is situated in an area that already suffers from alcohol related disorder, and underage drinking which is closely linked to anti social behaviour. In addition the premises is situated in a residential area and if granted will have a detrimental effect on the lives of nearby residents.

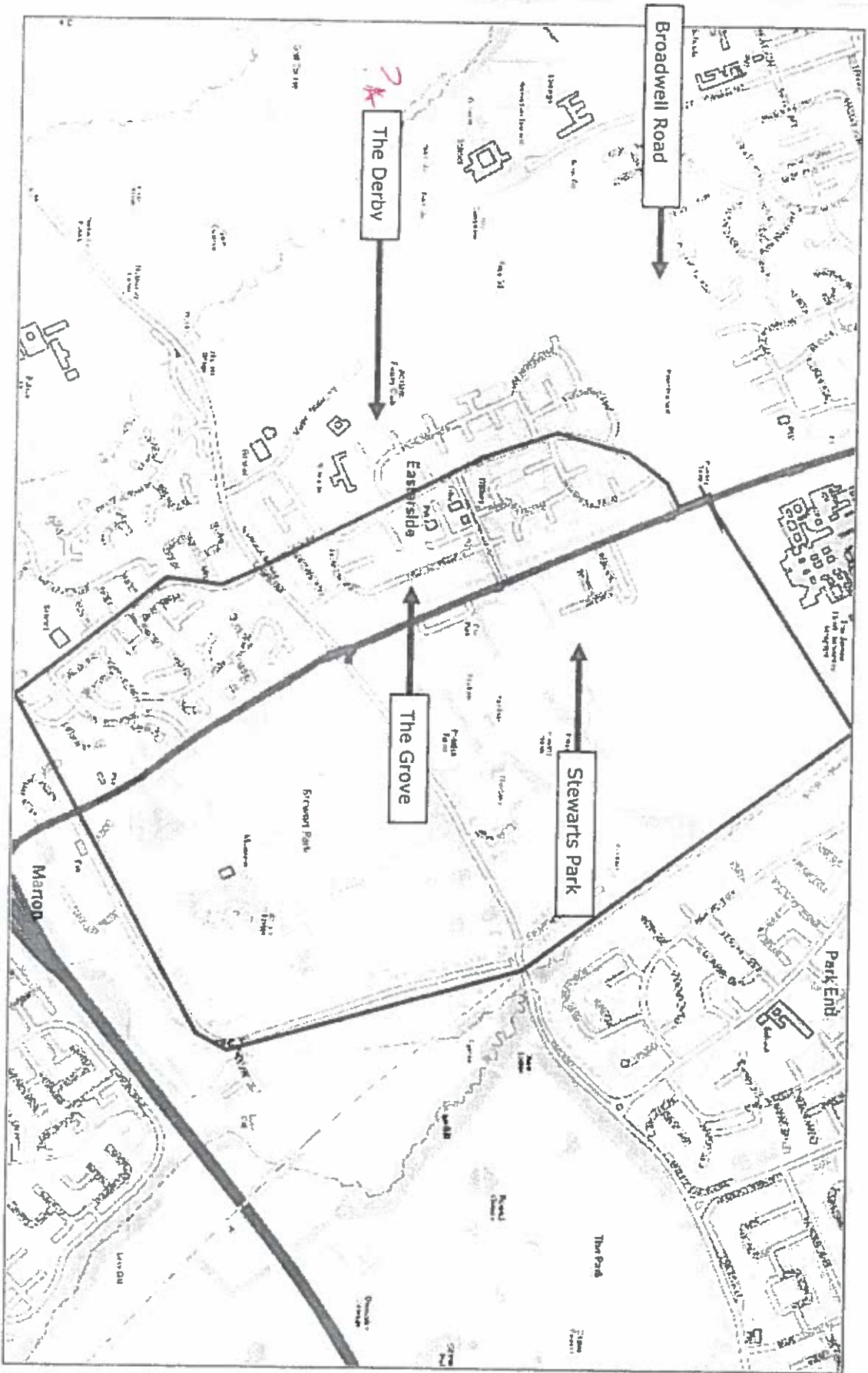



I am employed by Middlesbrough Borough Council in the post of Public Health Officer in the Improving Health and Wellbeing Service. I lead on delivering alcohol control issues across the town, working closely with key partners to deliver Middlesbrough's Alcohol Strategy. I have held this position since September 2014. Prior to this I worked in Middlesbrough Council's Licensing Section and held the post of Licensing Litigation Supervisor.

At 10pm on 22 February 2014 I was on duty with Louise Romaine, another Licensing Officer with Middlesbrough Council carrying out enforcement visits at licensed premises situated in the Middlesbrough area, in order to check compliance of licensing conditions.


At this time we visited premises named Tudor Lodge Service Station situated on Marton Road, Middlesbrough. This premise is authorised to sell alcohol between the hours of 6am and midnight, 7 days a week.

Upon entering the premise I identified myself to the male cashier who was working behind the counter area however the store was busy with customers at the time which meant that I had to wait to conclude my visit as there did not appear to be any other members of staff on duty at the time.



As I waited my attention was drawn to a number of youths who had entered the store. They were very rowdy and remained at the rear of the store out of sight. As a result I decided to walk up to the rear of the store to check what was going on. As I did so I looked down each of the aisles. As I got to the aisle where the sweets and crisps were situated I saw a male select a bag of crisps from the shelf and place them immediately into his jacket pocket. I describe this male as being white, approximately 16 years old, chubby build and was wearing jog pants, jacket and trainers. As I suspected that he was going to leave the store without paying for the goods I confronted the male and asked if he was going to pay for the crisps that he had placed in his pocket. The male immediately took the crisps from his pocket and put them back onto the shelf however as he was doing so he was joined by a number of males who I believed were his friends. I asked the males to leave the store as I believed that they were up to no good however as I walked with them towards the entrance/ exit door I heard other customers shouting towards the male behind the counter area to open the door. I realised that the doors had been locked by the male cashier. I immediately asked the male cashier to open the doors as I believed that if they remained locked it would cause the youths to become more confrontational. After several seconds the doors were opened and the customers and youths left.

I later spoke to the male assistant who identified himself as Mr Vinoth Muthusamy. He confirmed that he was the only person on duty at the time. I voiced my concerns to Mr Muthusamy as I believed that this incident could have escalated had he not opened the doors. I advised him that one of the conditions of the licence was to maintain adequate levels of staff at all times and advised him that one member of staff at 10pm did not seem adequate in my opinion.

During the visit all of the conditions attached to the licence were checked. It was identified that a number of conditions were not being complied with as Part B of the premises licence was not on display, there was no incident book in place, bottles of Lambrini, which is a perry based product was being sold and again in my opinion, there was not adequate numbers of staff on duty at the time. I advised Mr Muthusarmy of the breaches and before leaving the store I completed a premises licence inspection report and handed a copy to him. I hereby exhibit marked FMH/1 a copy of the said form.

On 25 February 2014 I received a telephone call from the premises licence holder who confirmed that the conditions were now being complied with.
