





LICENSES PREMISES APPLICATION - 13 PARLIAMENT ROAD, MIDDLESBROUGH

A gentleman named Mr Mourzzam Ali has applied to sell alcohol at the soon to be opened business in Middleborough at 13 Parliament Road. I oppose their application. There are a large number of other people and shops opposing their decision to sell alcohol there. I have being told confidentially the true person behind opening a business there is Mr Hardy Mhaudren Kareem.

Mr Hardy Kareem store already owner of two Polski Sklep shops, one two doors away of 13 Parliament Road called Polski Sklep and another also called Polski Sklep in Princess Road. Mr Kareem has had a long running battle to sell alcohol at each of his two stores turned down by Middleborough Council. He was turned down to a lot of crime and anti social behaviors happening around his stores.

So being turned down he has asked a friend named Mr Mourzzam Ali, and open the business in his name. Please refuse Mr Mourzzam Ali to conduct any business at 13 Parliament Road.

Already there large number anti-social behavior incidents and crime around these shops and area. Uniformed police, local street wardens already have already complained that there too many drunkards, prostitution, unemployed people, immigrants hanging in groups in this area, making it unsafe for everyone. Opening shops like this simply gives people to hang around all day long making people unsafe to walk the streets. By awarding a license to 13 Parliaments things are going to get much worse.

Other shops in area already disagree with this license application, this includes, Frydays Chips shop next door to 13 Parliament Road and Usmans newsagent over the road.

Ayresome Junior School would be hugely affected too. Young children quite often walk past these shops and are complaining about being hassled by gangs of adults, immigrants and drunkards and other unemployed people


There are already many other popular shops selling alcohol here. Directly opposite Usmans Newsagent already have license to sell alcohol. Further down the road large Tesco Express also in Parliament Road sells alcohol. Sainsbury's around the corner sell alcohol, so do AJ's corner shop in crescent road. These shops have even complained that more troublemakers tend to circle the area due to alcohol being sold there

Therefore I ask the Middleborough Council to support what I have written in this letter and refuse Mr Mourzzam Ali and his friend's license and permission to sell any alcohol at 13 Parliament, Middleborough.

## PREMISES LICENSE APPLICATION - 13 PARLIAMENT ROAD

Mr Mourzzam Ali has applied to sell alcohol at the soon to be opened premises at 13 Parliament Road. I as a home owner and a family man, the neighbours in the area and other shops nearby vehemently oppose the request for Mourzzam Ali to sell alcohol at these premises. The person who really is behind is Mr Hardy Mhaudren Kareem and his cousin Saman Abbasi. Mr Hardy Kareem store owner of two Polski Sklep shops, one in Parliament Road, and the other in Princess Road has already has had decisions to sell alcohol at each of Polski stores rightly turned down by Middleborough Council. This was due to large number anti-social behavior incidents and crime in the area. Having licenses turn down for each of his Polski sklep stores he has decided to use said person, Mourzzam Ali, and open the license and store under his name. Please refuse Mr Mourzzam Ali to conduct any business at 13 Parliament Road.

The neighbourhood has already has problems with regard to anti-social behavior in the area. The police and the street wardens already have their hands full in the area due to crime and prostitution, and street crooks loitering about. Already there are already far too many shops in the area with travel congestion, parking issues, and gangs of drunkards and street crimes happening, crime problems are simply getting worse day by day. Giving a license to 13 Parliaments are going to make crime problems further unbearable.

Shops in area already disagree with this application such as Frydays Fish and Chips shop at 11 Parliament Road and Usman newsagent, which is directly opposite 13 Parliament Road.

Local junior school and nursery, Ayresome Junior School would be affected by awarding a license to 13 Parliament Road. School children regularly walk past these shops and have complained about being hassled by groups of adults, immigrants and drunkards and other unemployed people. By awarding 13 Parliament a license it would give people an extra excuse to hang about these shops.

There are already popular shops in the area already having license to sell alcohol. Tesco Express also in Parliament Road already sells alcohol and has security guards to monitor any troublemakers. Another big brand name such as Sainsbury's around the corner in Crescent road sells alcohol. Local AJ's corner shop in crescent road sells alcohol. In fact Usmans Newsagent also sells alcohol and therefore another shop is not needed.

In conclusion, I am asking the Middleborough Council to please listen to the police, other shops in the area and the local residents to refuse Mr Mouzzam Ali a license to sell alcohol at 13 Parliament Road.


Relevant licencing objections applicable to the application:



I am writing to you in relation to the above application which you have recently made to Middlesbrough Council Licensing Authority.

On 14 December 2015, a letter was sent to you explaining that there is insufficient detail in your application to demonstrate how the operation of your premise will uphold the licensing objectives.

In addition, it was also explained that Middlesbrough Council has recently approved a Cumulative Impact Policy for the Newport ward and four other town centre wards, due to the high density of off licence premises in this area and the negative impact on the licensing objectives. This policy will be adopted on January 7th, 2016. Your premise is located within this Cumulative Impact Policy area and it is our opinion that your application should demonstrate how this premises will not negatively impact on the licensing objectives.


During our telephone conversation on 23<sup>rd</sup> December, I explained the above to you again and that further information about the operation of the premises should be submitted to the Licensing Authority to support your application. To date, no further information to demonstrate how you would promote the licensing objectives has been provided.

Therefore, I am advising you that a representation has been submitted to Middlesbrough Council's Licensing Authority by the Director of Public Health, as the Responsible Authority for Health in relation to the above application. This representation is made on the grounds that the application does not demonstrate how the premises will uphold the

licensing objectives, in particular, crime and disorder, public nuisance and the protection of children from harm.

# Evidence presented by Middlesbrough Council, responsible authority for health, against the application for a premises licence in respect of premises situated at 13 Parliament Road, under the Licensing Act 2003

The Director of Public Health, as the Responsible Authority for Health, is making a representation to this application on the grounds of Crime and Disorder, Public Safety, Public Nuisance and Protection of Children from Harm. The area in which these premises are situated suffers from high levels of alcohol related Crime and Disorder, Anti Social Behaviour and there are high numbers of wholly attributable alcohol related hospital admissions to James Cook Hospital. It is our opinion that the granting of a new premises licence in this area would undermine the Crime and Disorder, Public Safety, and Protection of Children from Harm licensing objectives and will exacerbate the problems already experienced.

This premise is located within the Newport ward, which is one of the most deprived areas within Middlesbrough. There is high unemployment, low education attainments, a predominance of privately rented properties, some of the poorest in Middlesbrough, and a high prevalence of ill health. Alcohol arrest data shows that Newport ward is a hotspot area for alcohol related crime and that a high number of these cases have involved people drinking in the home.

Alcohol related data and intelligence has been gathered for the Newport ward. In 2014/2015, there were 209 wholly attributable alcohol related admissions from the Newport Ward to an inpatient bed at James Cook University Hospital. This figure is 53% higher than the second most offending ward in Middlesbrough, and 204% higher than the average alcohol related hospital admissions rate over the other 20 wards within Middlesbrough.

There is also a high density of off licensed premises situated within Newport ward – 22 in total. Approximately 60% of off licensed premises are situated within 5 ward areas of Middlesbrough: Central, Newport, Park, Longlands and Beechwood and North Ormesby. During 2014/2015 a high proportion of the alcohol related crimes, wholly attributable hospital admissions and crime and disorder incidents were recorded from these ward areas. This, together with the high density of off licence premises prompted the need for a Cumulative Impact Policy which was included in Middlesbrough Council's Licensing Policy 2016-2021 which was adopted on 7<sup>th</sup> January 2016. This Policy requires off licence premises applications to demonstrate how they will not add to existing crime and disorder issues within these wards.

There is little information in the application made by Mr Mourzzam in relation to the operation of this premises and how it will uphold the Licensing objectives. As a result, several attempts were made to discuss this application with Mr Mourzzam to obtain further information on how the licensing objectives will be upheld. Two conversations were held which covered the management of the premises, staff training and responsible retailing procedures. Mr Mourzzam made some suggestions on how he may amend his application, however he was not willing to put these in writing to the Licensing Authority. As such, his application remained unchanged.

\*\*

A survey carried out over the last 12 months obtained information regarding the type of alcohol sold, in particular higher strength beers, lagers and ciders sold from the off licences in the Newport ward. Some of these products cost as little 13p per unit of alcohol. (The Chief Medical Officer recommends a minimum unit price of 50 p per unit) and are highly attractive to risky or dependent drinkers. There are clear links between the availability of cheap alcohol, antisocial behaviour and crime and disorder. Whilst it is not illegal to sell high strength alcoholic products there is clearly a need to ensure that all alcohol products are sold responsibly to ensure the licensing objectives are upheld.

The area in which this premise is situated suffers from high levels of alcohol related crime and ASB, there is a high density of off licensed premises and a Cumulative Impact Policy in place. This application does not demonstrate how the proposed premises will not negatively impact on the licensing objectives.

There are concerns that the granting of this licence could contribute to crime and anti-social behaviour in the area. In particular there are concerns about the management of the business and how it will ensure that alcohol will be sold responsibly and legally. In their application, the applicant has stated some steps that they intend to take to prevent underage sales of alcohol namely Challenge 25, request for ID, refusals logs, training and CCTV. However when I met with the applicant ,Mr Ali, on 21st December 2015 to discuss these steps he was not able to provide any detail or documentation to provide evidence of the adequacy of these steps. No procedures or training provisions are in place at the moment and the applicant has not made any decisions regarding the CCTV system such as the number of cameras, or the areas they will cover, other than that he will want remote access. Mr Ali has not made any arrangements for the cctv system to be installed. In order to be effective training and systems to prevent underage sales need to be robust however, the applicant has not been able to provide any information to demonstrate that their proposed systems will be.

There is further concern regarding the management of the business. The applicant, Mr Ali, has said that both himself and his nephew would be responsible for the day to day running of the business. Mr Ali however has other business commitments, and could not confirm how much time he would be present at licensed premises each day. He acknowledged that it would be a limited time each day and he intended to check the cctv remotely aswell. The applicant advised me that 2 members of staff would be working at the premises, one member of staff yet to be employed, and his nephew Adam Ali who will oversee the operation of the business. Due to the opening hours they would operate a shift system 7 days a week. Neither of the staff have any licensing experience and no training has been provided. There is concern that the people running the business on a day to day basis, managing and making the sales of alcohol will have no licensing experience and have not received any training. Details of any proposed training have not been provided.

Concern over the management of the business is particularly pertinent given that this premise is in a Cumulative impact Policy Area. The applicant was asked in a letter dated 14th December 2015

and in the meeting of 21<sup>st</sup> December 2015 to provide evidence of what steps they would be taking to uphold the licensing objectives to ensure that their business would not exacerbate existing problems in the area. To date no such evidence has been provided. In the meeting on 21<sup>st</sup> December 2015 Mr Ali indicated he was aware of the alcohol related anti social behaviour in the area and acknowledged that the type of alcohol products sold could attract the wrong time of customer and exacerbate problems in the area. Whilst he confirmed that he did not want his business to contribute to alcohol related anti social behaviour in the area , when specifically asked what he would do, his replies were evasive. He said he would consider taking Perry and high strength alcohol products off the shelves if it was an issue but gave the impression that this would only happen if it was a condition on the licence.

In summary, there are concerns about the management of this business, namely a lack of effective control and experience in relation to the staff making the sales of alcohol on a daily basis. In addition the applicant has not provided information to demonstrate the adequacy of their proposed systems in relation to training, the prevention of underage sales and what steps they intend to take to ensure that their business will not have a negative impact ,increasing alcohol related crime and disorder in the area. For these reasons t am of the opinion that the application fails to demonstrate how they will meet the licensing objectives of "Preventing Crime and Disorder" and "Protection of Children from Harm".

Please provide as much information as possible to support the representation. (Please read guidance note 5.) Underage drinking is a major source of anti-social behaviour within Middlesbrough. A risk taking behaviour roadshow survey of Middlesbrough Schoolchildren aged 13-14 years in 2013-14 identified that 29.4% had drank alcohol and 12.1% had got drunk on alcohol to the point of losing control. In addition 89.3% believed that most people their age group drank alcohol at least once a month. The local Alcohol profiles for England show that between 2010/11-2012/13 the North East had the highest levels of alcohol specific hospital admission for under 18s in the country and Middlesbrough had the 6th highest rate in the North East . Middlesbrough was ranked as having the 22nd highest hospital admissions for under 18's out of all the authorities in England.

I am writing as the Trading Standards contact and designated 'Responsible Authority'in receipt of a completed copy of your application for a licence under the Licensing Act 2003 for the above mentioned premises.

In order to assess your application fully I need further information about the systems that you intend to operate to prevent underage sales. I therefore requested a meeting with you.

In addition It also require you to provide me with more information which demonstrates how you, as a responsible retailer, will promote the licensing objectives and not add to the existing problems of crime and disorder already encountered in that area.

Middlesbrough Council has recently approved a Cumulative Impact Policy which will be published in January 2016. This Policy ensures that further off licence premises applications do not add to existing crime and disorder issues within these wards.

During our telephone conversation today I tried to set up a meeting with you next week to discuss this matter but you were not available after this week until the new year and I therefore arranged a meeting at 9am Friday 18<sup>th</sup> December 2015 at Vancouver House, Gumey Street, Middlesbrough. As discussed this meeting will go ahead on that date and time unless the court case I am attending at the Magistrates court is completed early in which case I may be able to rearrange this meeting for Wednesday afternoon instead. As mentioned in our conversation I will not know if this is possible until late Tuesday afternoon. I will contact you on Tuesday evening to confirm.



Could you bring along to the meeting all your documentation, particularly in relation to your systems and training to prevent underage sales.

If this is not possible can you please provide me with all additional information including the information about how you will promote the licensing objectives and not add to the existing problems of crime and disorder in that area ,by no later than the 22nd December 2015.

I am concerned that the granting of this Premises Licence will impact on the four licensing objectives as Part M of your application fails to demonstrate how you will promote them. If you fail to provide the requested information, it is likely that the matter will need to be resolved by the Council's Licensing Committee, by way of a hearing.
