### 3. Legislation

The Licensing Act 2003 requires the Licensing Authority to carry out its functions with a view to promoting the four licensing objectives:

- The Prevention of Crime and Disorder
- Public Safety
- The Prevention of Public Nuisance
- The Protection of Children from Harm

The Licensing Authority must also have regard to its Licensing Policy and any guidance issued by the Secretary of State.

### 4. Background

These premises operate as a newsagent and convenience store and have applied for a licence to be able to sell alcohol for consumption off the premises which would enable them to operate as an off licence as well.

Members are advised that the applicant, Mr Singh, has now applied for and been granted a personal licence to enable him to be the premise supervisor.

Members are advised that these premises are located in Central Ward which has been identified as a Cumulative Impact Area in relation to Off Licensed Premises within the Council's Statement of Licensing policy. A location plan is attached at Appendix 2.

#### 5. The Representations

On 25 June 2016, a representation was received from Councillor Linda Lewis and Councillor Zafar Uddin objecting to the application on the grounds that granting the application would undermine the four licensing objectives as the premises are located in a Cumulative Impact Area. A copy of that representation is attached at Appendix 3.

On 13 July 2016, a representation was received from Cleveland Police on the grounds of the prevention of crime and disorder, and the prevention of public nuisance and the fact that the premises are located in a cumulative impact zone. (see Appendix 4).

On 14 July 2016, a representation was received from Trading Standards on the grounds of the prevention of crime and disorder and the protection of children from harm (see Appendix 5).

On 18 July 2016, a representation was received from the Director of Public Health on the grounds of the prevention of crime and disorder, the prevention of public nuisance, and the protection of children from harm (see Appendix 6).

- 2. To refuse to specify a person in the licence as the premise supervisor
- 3. To reject the application.

Members are reminded that any aggrieved party (i.e. Applicant, Responsible Authority/other persons who have made a representation) may appeal any decision of the Licensing Committee to the Magistrates Courts.
