

1. Strict implementation of challenge 25 policy
2. CCTV to be installed and 31 days recording system
3. All staff to be trained in responsible alcohol retailing
4. Training manual will be available at the premises

b) The prevention of crime and disorder

1. CCTV to be installed inside and outside the premises with 31 days' storage system
2. CCTV images provided immediately to Police when requested
3. Cash in tills kept to a minimum
4. Till will be secured to the counter so customers cannot reach over
5. All stock to be bought from reputable cash & carry/wholesalers
6. Incident book available on premises
7. No alcohol drinks or tobacco will be purchased by the premises from unannounced sellers calling at the premises
8. No cannabis grinders, pipes which could be used to smoke drugs, rolling papers or pre-rolled blunts to be sold within these premises. Or any items who's primarily use could assist in supporting drug uses or drug addicts.

c) Public safety

1. Installation of a appropriate safety equipment
2. Fire exit signs displayed
3. To comply with all current, fire and health safety laws
4. CCTV working always

d) The prevention of public nuisance

1. Posters displayed to show CCTV monitoring anti-social behaviour.
2. Notice displayed asking customers to leave quietly from premises also customers will be told in person to leave quietly and not to disturb local neighbourhood.

e) The protection of children from harm

1. Staff to be trained regularly in underage sales prevention
2. Challenge 25 Policy in place.
3. Challenge 25 posters displayed where alcohol is sold
4. "NO PROOF OF AGE – NO SALE" signage displayed
5. Alcohol kept away from confectionary shelf
6. Refusal book kept at premises and updated on every occasion when alcohol is refused to an underage.

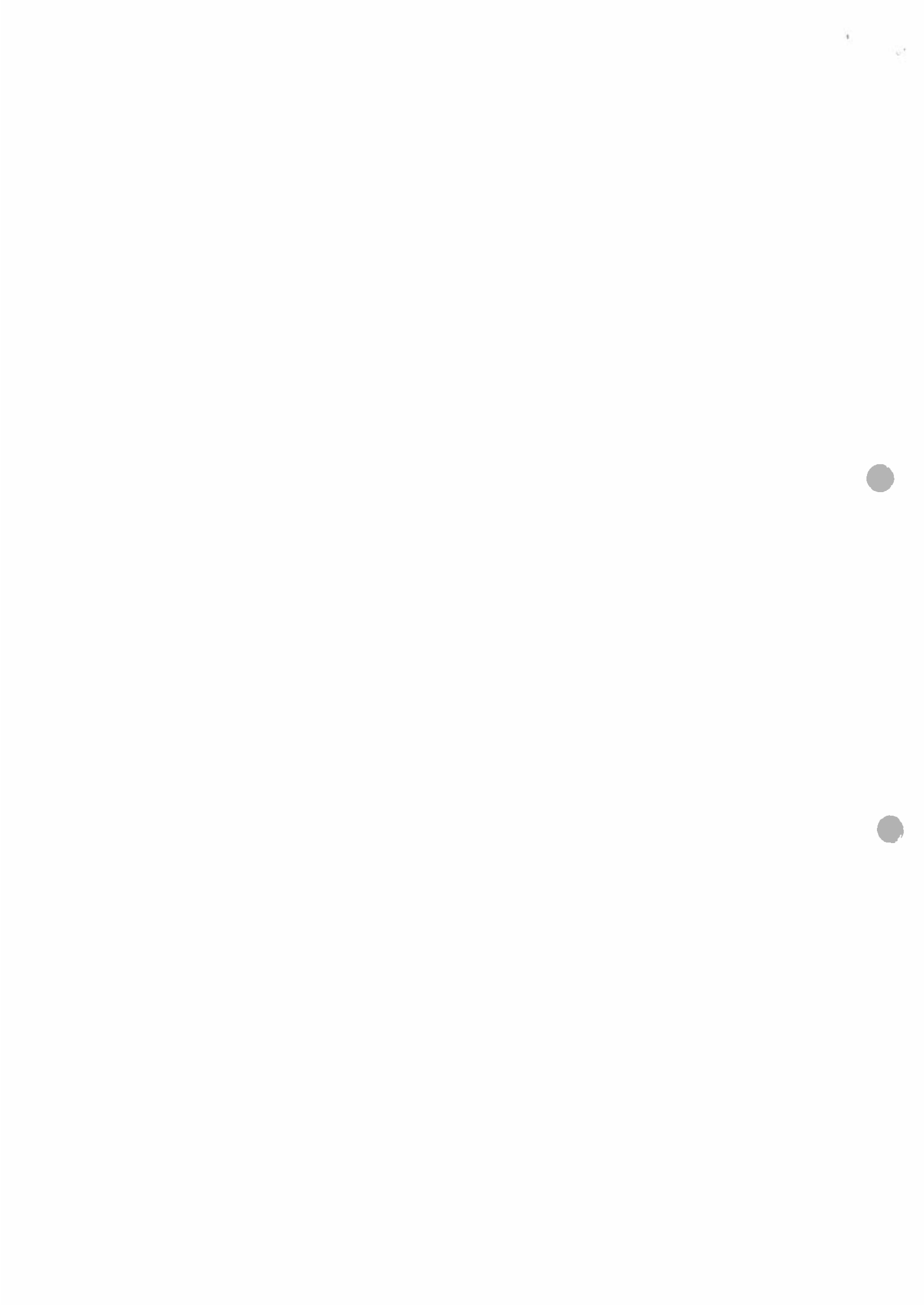

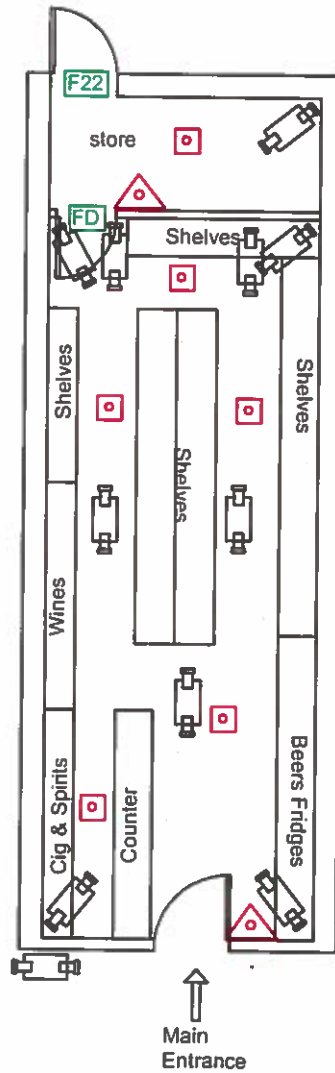
