#### PURPOSE OF THE REPORT

#### BACKGROUND AND EXTERNAL CONSULTATION

3. The Board will be aware that as part of the scrutiny processes, the Executive at its meeting on 6 July 2004, considered the findings of the Scrutiny Panels listed in paragraph 1 above in relation to their final reports on a number of topics.
4. In addition to those reports, two other reports were also considered, the Council branding report was considered alongside an Executive report at the meeting held on 20 July 2004, which incorporated the service response.
5. Due to time constraints the Clairville Stadium report was presented directly to the Executive Board when considering the original report. Consequently the service response was tabled at the meeting and did not go through the CMT approval process.
6. This report represents the formal notification to this Board of the Executive's decisions in respect of the reports.

7. In that regard, in addition to all the Panel reports, the Executive also considered the service responses together with the views of the Corporate Management Team (CMT). CMT agreed to support the Service Response in respect of all the final reports. The Council Branding report was also considered at CMT alongside the scrutiny report and CMT agreed to support the Service report.

The former Chairs of the Education, Skills and Jobs and Social Care Scrutiny Panels presented their Panel reports to the Executive and the Chair of the Overview and Scrutiny Board presented the Resources and Audit Panel's report at the Executive meeting on 6 July 2004. The Chair of Community Safety and Leisure Scrutiny Panel presented his report to the Executive on 3 August 2004.
9. In welcoming the reports produced by the Scrutiny Panels, the Executive agreed to approve the service responses in all cases.
