### DRAFT - CORPORATE PERFORMANCE PLAN 2005 / 2006

#### Panel Responses

#### PURPOSE OF THE REPORT

- 1 To inform Members of the Overview and Scrutiny Board of the responses from individual Scrutiny Panels who have considered the aspects of the Corporate Plan which fall within their remit.

#### RECOMMENDATION

- 2 It is recommended that the Overview and Scrutiny Board considers the responses of the Panels and forms the collective Scrutiny Response to Corporate services for consideration when finalising the 2005 / 2006 Corporate Plan.

#### RESPONSES FROM THE INDIVIDUAL PANELS

3. The Corporate Plan 2005 / 2006 has been presented to the individual Scrutiny Panels for their attention. The following briefly outlines the key areas highlighted by each Panel. However, the timetable for Panels to address this issue is such that the detail has been unable to be conveyed in advance of circulation of this agenda and report. Consequently those Panels will report at the meeting.

#### ENVIRONMENT SCRUTINY PANEL

4. The panel met on 20 April to discuss the relevant chapter of the Corporate Plan. A copy of the Corporate Performance Plan 2005/06 was distributed to the Panel, in addition to a report outlining the background and the requirement to seek the views of the Scrutiny Panel. The report contained an Annex that identified the theme

'Transforming our Local Environment'. This Annex identified the priority contributions to the Community Strategy theme and the Mayor's Reduction Agenda.

5. The Panel was presented with the key achievements against the priority contributions to the community strategy themes that were identified in 2004/05 and were also presented with the planned actions in 2005/06 to address strategic priorities.
6. Members of the Panel were asked if they identified any omissions in the report or if they wanted to add any emphasis. No requests for omissions or emphasis were made, however Members did ask numerous questions.

#### **SOCIAL CARE AND ADULT SERVICES SCRUTINY PANEL**

7. The panel was due to meet on 19 April to discuss the relevant chapter of the Corporate Plan however the meeting was inquorate and therefore rearranged to 3 May. Comments will therefore be conveyed at the OSB meeting on 3 May.

#### **ECONOMIC REGENERATION AND TRANSPORT SCRUTINY PANEL**

  - Any minor changes can be agreed by the panel without further recourse to OSB
