It was suggested that the findings of the independent examination on such a system currently being undertaken be presented to a subsequent meeting of the Board.

2. That the findings of the independent examination of the 'One Stop Shop' be presented to a future meeting of the Overview and Scrutiny Board.

3. That the suggested topics identified at the meeting of the Board held on 14 June 2005 for possible inclusion in the Board's work programme be considered at the next meeting of the Board scheduled for 12 July 2005.
