### **\*\* MINUTES**

## **SCRUTINY REVIEW - IMPLEMENTATION OF RECOMMENDATIONS**

The Senior Scrutiny Officer submitted a report which outlined progress achieved in relation to the implementation of agreed Executive actions resulting from the consideration of Scrutiny reports.

In terms of the Executive actions which should have been implemented by October 2005, 147 had been implemented, 28 partially completed and progress reports received in respect of 8 out of 10 actions which had not been implemented.

Appendix B of the report submitted gave an update in respect of the Health Scrutiny Action Plans.

Reference was made to the extent of information provided for each Scrutiny Panel and the opportunity for them to consider the impact following the implementation of such recommendations.

## **SCRUTINY REVIEW – NON EXECUTIVE MEMBER – COMMUNITY DEVELOPMENT WORKERS**

The Senior Scrutiny Officer submitted a report which outlined a request received from a Non Executive Member for a review to be undertaken into the role of Community Development Workers.

Members suggested that should the topic be approved it would be beneficial if it was examined following consideration of the outcome of the Community Engagement Ad Hoc Scrutiny Panel's investigations.

**ORDERED** that approval in principle be given to the inclusion of a scrutiny topic for a review into the role of Community Development Workers into the work programme of the Economic Regeneration and Transport Scrutiny Panel at the earliest opportunity in the next Municipal Year 2006/2007.

## **SCRUTINY REVIEWS - CONSIDERATION OF REQUESTS**

It was confirmed that no requests for scrutiny reviews had been received from the Executive, Executive Members or members of the public since the last meeting of the Board.

## **SCRUTINY PANELS - PROGRESS REPORTS – ACUTE SERVICES REVIEW**

A report of the Chair of each Scrutiny Panel was submitted which outlined progress on current activities.

The Chair of the Health Scrutiny Panel referred to the review being undertaken by the Joint Section 7 Consultation Committee into the Acute Services Review following a report from Professor Sir Ara Darzi. In accordance with the proposed timetable a final report was to be formulated by mid January 2006.

The proposals, which were currently being consulted upon related to hospital based services in the Tees Valley, which also affected residents from North Yorkshire and parts of Durham.

In order to assist the scrutiny process the Board considered the feasibility of the Executive as distinct from any scrutiny perspective examining the possible impact of the proposals for the residents of Middlesbrough.

**ORDERED** that the Executive, at its meeting to be held on 20 December 2005 be asked to consider formulating a view on the possible impact on the residents of Middlesbrough of the proposals by Professor Sir Ara Darzi as part of the Acute Services Review.
