# DEVELOPING THE SCRUTINY PANELS' WORK PROGRAMMES

  - 7<sup>th</sup> June Member Development "Effective Overview and Scrutiny"
  - 19th June to 2nd July All Panels receive intro from the Service Area
  - 21<sup>st</sup> June All Non Exec Members "Topics for Scrutiny"
  - 27<sup>th</sup> June Member Development "Skills for successful Scrutiny"
  - June/July Panels meet to determine the 07/08 work programme
  - 3<sup>rd</sup> July Second OSB to discuss potential work programme.

- 4. The meetings of the 21<sup>st</sup> June were to receive direction from the Chair of OSB regarding potential subjects for including into the Panels future work programme. The meetings also provided the opportunity for members to openly consider and debate a range of options and suggestions raised by members, which would be directed to the individual Scrutiny Panels for their consideration.
