# **REVENUE OUTTURN 2006/2007**

The Director of Resources submitted a report, which outlined the final outturn position for expenditure against the 2006/2007 Revenue Budget.

A detailed breakdown was given of each Service areas' outturn position together with a summary of the position relating to corporate costs and central provisions.

The overall service outturn variances from budget were summarised as follows: -

Although a number of budget pressures within certain Service areas were highlighted it was noted that each Service Department had remained within budget.

The Board sought clarification on a number of areas including:-

 a) although improvements had been made to the overall situation in respect of the vulnerable children budget reference was made to important ongoing work to address the remaining budget pressure areas;

- b) an indication was given that there may now be no claw back in relation to the significant underspend in respect of the Sure Start Grant;
- c) in order to address current problems associated with the lack of foster carers reference was made to significant ongoing work which included an examination of the range of placements available;
- d) it was confirmed that there were robust systems of stepped levels of internal control in place for all grants depending on the size and different funding regimes of schemes.

In response to a number of queries the Director of Resources confirmed that further information would be provided in respect of the following:-

- i) percentage of children in care and number of external and residential placements;
- ii) Council's Fostering Allowance Scheme;
- iii) distinction between the Early Years and Childcare Management and Management Support sections within the Family Services area of CFL;
- iv) Members' Allowance Budgets.

#### CONSOLIDATED PERFORMANCE CLINIC REPORT YEAR ENDING 31 MARCH 2007

A report of the Principal Corporate Development Officer was submitted which outlined the Council's performance for the year ending 31 March 2006 in relation to:

- Key Planned Actions given in the 2006/07 Strategic Plan;
- Best Value Performance Indicators (BVPIs)
- BVPI targets set for 2007/08.

Details of performance were provided as follows: -

Appendix A: against each Planned Action; Appendix B: BVPIs that met the target set;

Appendix C: BVPIs that did not meet the target set; Appendix D: BVPIs set for the next three years.

The main findings were reported that the Council had performed well in delivering its key planned actions and improving performance in the suite of BVPI's in particular:

- 91% of key planned actions were achieved (149 out of 163) which included six within a longer timescale;
- 53.1% of BVPIs met or exceeded the target set;
- 69% of BVPIs improved or remained the same (2006/07 performance compared to 2005/06 performance);
- it was the fourth consecutive year in which performance in approximately two-thirds of BVPIs had improved or remained the same.

The Key Planned Actions that were not achieved or were not achieved within timescale mainly related to Key Planned Actions where over-ambitious targets had originally been set.

In terms of the 2006/07 suite of BVPIs, 77 (53.1%) had met the target set and 68 (46.9%) did not meet the target set. It was noted however that some of the targets set had been extremely challenging, in particular, educational attainment and diversity related targets.

Members sought clarification on a number of areas specifically those cases where the Key Planned Actions and the BVPI targets had not been achieved. It was suggested that a summary of such areas could be provided.

Although a number of targets had not been met in respect of Children, Families and Learning the Board was advised that in overall terms the figures had shown improvement. It was reported that in a number of cases there had been a low baseline and targets imposed.

## ORDERED as follows: -

- 1. That the information provided be noted.
- 2. That further information be provided on a summary of Key Planned Actions and BVPI targets which had not been achieved.
