## CHIEF EXECUTIVE

#### PURPOSE OF REPORT

#### BACKGROUND

- 2. The Board will be aware that as part of the scrutiny processes, the Executive at its meeting on 7 October 2014 considered the findings of the following Scrutiny Panel Reports:
  - Community Safety and Learning Scrutiny Panel's final report on Protecting Children from Sexual Exploitation;
  - Economic Regeneration and Transport Scrutiny Panel's final report on Business and Job Creation;
  - Health Scrutiny Panel's final report on Access to GP Surgeries, and
  - Social Care and Adult Services Scrutiny Panel's final report on Continuing Healthcare (CHC) Provision – To Ensure the Health Economy Funds Health Needs.
- 3. This report represents the formal notification to the Board of the Executive's decisions in respect of the reports.
