TEESWIDE SAFEGUARDING ADULTS BOARD - DEVELOPMENT OF STRATEGIC PLAN - CONSULTATION

PURPOSE OF THE REPORT

1. To present information on the above subject and to seek the Overview and Scrutiny Board's (OSB) views on the matter.

RECOMMENDATION

BACKGROUND

- 3. The Teeswide Safeguarding Adults Board (TSAB) has been established to ensure that adults at risk across Teesside are protected and safeguarded. Since April 2015 it has been the statutory body in respect of this function.
- 4. The Board brings together representatives of each of the main agencies responsible for protecting adults from abuse and neglect and includes representatives of all Tees Valley local authorities. It is responsible for developing, monitoring and reviewing adult protection policies, procedures and practice and for commissioning inter-agency training for staff who work with vulnerable adults across the Boroughs of Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees.
