PURPOSE OF THE REPORT

- 1. The purpose of the report is two-fold:
 - i. To inform Members of the Overview and Scrutiny Board of the work programmes proposed by each of the scrutiny panels for 2015/16.
 - ii. To consider and agree topics for examination by the Overview and Scrutiny Board over the course of the municipal year.

RECOMMENDATIONS

- 2. It is RECOMMENDED that the Overview and Scrutiny Board:
 - i. Considers the range of topics identified by the individual scrutiny panels for inclusion in 2015-16 work programmes and approves/amends these as appropriate.
 - ii. Agrees a list of topics for examination by the Board during the course of the year, with an indication of whether these should be examined by the Board, by the Ad-Hoc Scrutiny Panel or by Task and Finish Groups.

PROPOSED SCRUTINY PANEL WORK PROGRAMMES

3. Proposed topics put forward by the Council's scrutiny panels are set out below. These have been considered and agreed by each of the panels following meetings held in July 2015.

a. Children and Learning Scrutiny Panel

- Prevention services in Adult Social Care.

- 4. The committee will meet on 31 July to establish its annual work programme. In accordance with the agreed rotation procedure, the Chair for the Joint Committee for 2015/16 will be appointed by Redcar and Cleveland Council.
- 5. The committee's work programme will be reported to Overview & Scrutiny Board in due course.

- 6. Members will be receiving information and updates on the following topics
 - IMProVE (Integrated Management and Proactive Care for the Vulnerable and Elderly).
 - Lifestore.
 - Urgent Care.

POSSIBLE TOPICS FOR EXAMINATION BY OVERVIEW AND SCRUTINY BOARD

- 7. In addition to the topics that are examined by each of the scrutiny panels, further subjects are also generally examined by the Overview and Scrutiny Board throughout the year. For example, these may be cross-cutting topics that overlap the work of more than one scrutiny panel, or focus on corporate issues affecting the Council.
- 8. Such issues can be examined by the Board as a whole; by the Ad-Hoc Scrutiny Panel; or (as was the case in 2014-15) by Task and Finish Groups comprising a small number of Members. In addition to undertaking the agreed work programme, scrutiny panels have also previously responded to emerging issues such as considering relevant new legislation, guidance or Government consultation documents. This approach can result in further topics being identified for investigation or review during the year.
- 9. Agreed topics may be investigated as detailed scrutiny reviews over the course of several meetings, or as shorter topics over one or two meetings. Updates on scrutiny topics previously considered may also be requested.
- 10. OSB should also ensure that the agreed work programme is not overly ambitious so that it can be delivered within the municipal year alongside consideration of the remainder of the Board's business.
- 11. Scrutiny topic suggestions appropriate to the work of the Overview and Scrutiny Board have been received as follows:
 - a) The town's commitment to honouring its signing of the armed forces covenant in relation to social provision.
 - b) Financial inclusion.

- c) The method for collecting unpaid council tax and the use of bailiffs. In particular the cost to the individual, the level at which action is taken and time scales from notification of arrears to formal court action.
- d) Ayresome Industries Business model, strategic direction and opportunities for development.
- e) Tied accommodation Management, allocation and security of tenure.
- f) Training/education for Councillors Mandatory and voluntary (particularly with reference to equal opportunities; what constitutes bullying and harassment; media training; accreditation of training).
- g) Scrutiny on scrutiny Purpose and Achievements.
- h) Skills audit for staff and Councillors.
- i) Verbal/physical abuse of frontline staff Is this issue on the increase and what is the council doing to promote safety?
- j) Cross-agency and authority working How can we work together to make service improvements?
- k) Community Councils Expenditure; value for money; do they all operate in the same way; look at other areas and see how they do it.
- I) Council use of consultants.
- m) Establishment of a Council Access Group/Forum for people with disabilities eg to involve them in issues such as planning procedures, new project development, campaigns to promote facilities and services for disabled people, access to paths and rights of way, provision of accessible buildings.
