TEESWIDE SAFEGUARDING ADULTS BOARD - UPDATE

PURPOSE OF THE REPORT

1. To receive information from the Chair of the Teeswide Safeguarding Adults Board as part of the Board's local accountability arrangements.

RECOMMENDATION

2. That the Overview and Scrutiny Board receives the submitted information.

BACKGROUND

- 3. The Teeswide Safeguarding Adults Board (TSAB) was established to ensure that adults at risk across Teesside are protected and safeguarded. Since April 2015 it has been the statutory body in respect of this function.
- 4. The Board, which has an Independent Chair, brings together representatives of each of the main agencies responsible for protecting adults from abuse and neglect. It is responsible for developing, monitoring and reviewing adult protection policies, procedures and practice and for commissioning interagency training for staff who work with vulnerable adults across the Boroughs of Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees.
