#### The initial issue Checklist

1 Are the concerns to do with the quality of public service provision at a local level?

This Councillor Call for Action is to address concerns in the community about the lack of playing fields & football pitches, this a ward already blighted by high rates of crime & disorder, antisocial behaviour. The loss of the play fields and football pitches will contribute to the already high rates of obesity and the associated health problems/risks associated with such.

2 Are the concerns individual complaints?

These are not relating to an individual or individual complaints, this is supported by the attached letters and also a petition of over 3,000 signatories..

Do the concerns relate to individual 'quasi judicial' decisions (e.g. Planning or Licensing) or to Council Tax or Non-Domestic Rates?

No, it does not however, in part also relate to the lack of safeguarding of local football pitches by Middlesbrough Council and failure to engage with both Sport England & the Football Foundation who have a beneficial interest in the land. These organisations have provided a grant to Middlesbrough Council to ensure a legacy of play fields and football pitches are retained in perpetuity to help tackle the concerns raised above and reduce the impacts of inactivity.

#### The Local Community Concern Checklist

- 4 Is the focus of concern on a neighbourhood or locality issue?
  This Councillor Call for Action is not only a neighbourhood issue but also a locality issue.
- Is the issue a genuine local concern?

  It is of genuine concern and has been reflected by both the attendance at numerous public meetings, signatories to the petition [3,000+] and the number of telephone calls, emails and face to face discussions with residents held by all ward councillors.

#### The 'Championing a Request' Checklist

#### 6 Resolving an issue.

The future of the Southlands Centre has been raised in writing to the Section 151 Officer and ignored, it has been raised at face to face meetings with both the internal & external auditors.

There is a petition but it cannot effectively, deal with the wide ranging community concerns. A petition is not a mechanism for dealing with information that has not been presented to the Executive and omitted from reports.

The Community Concerns are justified when both Overview & Scrutiny Challenge, onestops and a letter to the Section 151 Officer did not get open, transparent and full answers.

It was a separate approach to the Football Foundation based upon the community's concerns coupled with a Land Registry search that satisfied this.

## When an apology, explanation or an assurance about a particular problem is enough to satisfy a community concern.

This is not applicable as the failings that have caused community concern are embedded so much so the auditors are still monitoring policies, processes.

The councils complaints process is not a suitable mechanism given the involvement of senior officers including the CEX about the future of the Southlands Centre.

### 8 If the above are not appropriate or have been tried and not succeeded.

 We have raised the issue with any local stakeholders who use the centre including but not limited to dance groups;

We have held a number of public meetings inviting the local community to attend, we have taken onboard their concerns, had informal discussion and also formal public meetings with Executive members in attendance. Minutes of these meetings have been recorded and are available upon request.

 We have raised this issue at the local Community Forum and held a number of meetings discussing this topic. The community concerns are reflective of those submitted.;

 We have raised concerns with the appropriate Executive member in writing and unfortunately ;have not received an open and transparent response to concerns raised. We cannot raise concerns with the Executive Member about the beneficial interest in land of the Football Foundation or the interest of Sport England. It has never been a material consideration of the Executive member and officers, this is evidenced by its omission from reports.

Middlesbrough Council does not have a dedicated scrutiny officer and the matter has been picked up by Mrs Reynolds. The guidance has been updated by Mrs Reynolds without referral back to the committee nor delegated power to do so, in our opinion.

#### The 'Reality' Checklist

#### 9 Be selective

Only agree to take on issues that have wide support: don't forget that for every group of residents that support a particular scheme, there will probably be another group that oppose it. Don't set yourself impossible objectives - don't set yourself up to fail.

Councillor Calls for Action are not a pathway to additional funding. If the Council has already decided not to take a particular course of action it might well be that the funding is not available. Use the One-Stop to get information BEFORE committing yourself to a particular course of action.

#### SECTION 2: HOW TO PROGRESS A CCfA

- 2.1 The members have been provided with the initial letter stating intention to progress a councillor call for action..
- 2.2 CCfA is the only option to address local need there have been a number of opportunities to address local need such as playfields and football pitches but in the absence of officer's and Executive Members approaching those with an interest in the land, discussing with them before proceeding down a course of action, no other route is available. Scrutiny is the only resolution available due to all other avenues being exhausted and the officers and members mentioned above being involved.

- submitting a One-Stop is not appropriate as the officers and members had not carried out sufficient due-dilligence to indentify local concerns or attempted to engage with interested parties.
- A complaints procedure is not appropriate as the head of paid Service has had direct input into this decision which has resulted in the community concerns.
- Advise has been provided regarding a petition but a petition will not and does not address the concerns of the community.
- 2 Call in's have previously taken place and on each occasion audit found that the concerns of the MICA group, residents, businesses and community were valid but this was still ignored by Middlesbrough Council.
- 2.5 This is our formal request that the CCFA is advanced to committee for the reasons stated in the boxes below;

The council since 2014 have failed to comply with its own policies and procedures governing the future of the Southlands Centre.

When Executive members have been furnished with reports information has been omitted.

When Officers have been challenged about the omissions they have failed to satisfy the concerns of auditors. Middlesbrough Council have not engaged with all stakeholders. community groups, community users, the business community or residents about the future of the Southlands Centre. There has been no mention in any report of communication with the Football Foundation or Sport England, in fact this was instigated by the MICA Group following a Land Registry search after the local community raised concerns. There has been a vaque promise of a community facility but sadly this has not been costed and no information has been provided. It was however a consideration of the Executive to decide the future of the Southlands Centre on this basis.

There has been no material consideration or engagement with Sport England or the Football Foundation about the communities concerns over the loss of playfields and football pitches [both 3G and grass].

There has been no consideration or reference to the shortage of playfields and pitches in Middlesbrough despite the authority being aware of the issue. It was stated by the Executive Member for Finance & Governance that this will be sold for housing.

Due to the lack of process and governance compliance, the Head of Paid Service & Executive members involvement throughout the process it is only suitable for independent scrutiny.

I am the Principal dance teacher at *Steps School of Dance*, based in Ormesby. We are a small friendly dance school and often take part in shows and competitions based in the Southlands Centre. There are dance events on almost every weekend and most half term holidays, with up to 600 people often attending these festivals.

There were so many activities available when I was a child attending this centre and at many other local facilities, including the Netherfields community centre. The Southlands had such a variety of activities available, from roller skating to trampolining, gymnastics, play schemes, football, basketball and so much more. There was something for everyone and every age. This inevitably kept me on the straight and narrow and helped me gain so many life skills. New sessions, classes which have recently set up are constantly under threat of the Southlands centre closing; which is the reason most businesses have moved out and sessions aren't as busy as they could be.

There are very few facilities with such a wonderful Theatre stage and venue which can support functions such as Championships,
Dance Festivals, Shows, Fitness events, parties and so much more. The business could be thriving in this centre, the location is
fantastic and all the council wat to do is knock it down to build houses and make more money. We need to work together to try and
save our Centre and the facilities it has to support our activities, jobs and everyday life. Even if people could travel further afield, there
simply isn't enough space for Everyone and every event. I don't think anyone has done the maths!!! Millions of pounds have just been
set aside at Parliament for various Arts, including dance and we have no facility to Display this or educate locally.

This is already an overpopulated area with no local facilities and the loss of our centre will have a devastating effect on our local community as well as to many from further afield. Not only will this mean a loss of jobs, businesses, activity groups and a local community meeting point; it also means the loss of an amazing Theatre Hall. I bring my children to sessions on a weekly basis, as a local resident I don't want to see more children on the streets causing havoc, this is something already out of hand in this area. I can't see it getting any better by adding to a broken community without the support of activities. There are so many youngsters who have ASBO's and cause so much terror in our area, this will only rise without activities available at a reasonable price. Children are becoming obese more and more and also struggling with education.

It's a known fact that daily activity reduces stress, increases a healthier mind therefore will help improve learning and reduce obesity and Type 2 Diabetes. The cost of these illnesses cost the NHS money that would be better spent in the prevention rather than correction of peoples wellbeing. If a like for like building is built in the place of Southlands will it have the Theatre stage, Sports Hall etc.? I doubt it. We have lost so many local centres in the last few years, there has never been an alternative or new facility in its place, it's a disgrace. What will be available for my children aged 5 & 9 and myself and partner to attend? Neptune already have waiting lists for lots of sessions as does the Sports Village. Also the cost of public transport to these facilities is extremely expensive and not affordable to many of the community. I hope that we will save this centre and make it the thriving business centre it once was.

To Whom It May Concern

I opened the café in Southlands Centre in April 2013 and for the whole 5 years the centre has been under threat of closure. I employ one permanent member of staff plus myself and occasionally I take on a third person as and when needed. I chose to open a business in Southlands because of the lack of a café in what was at the time a thriving Leisure/Business Centre, its location (5 minutes' drive from home), cheap rental fees, free parking and opening hours suitable for my requirements.

The majority of my customers come from within the centre itself, although we do have some regular customers who come from outside the centre, but over the past two years my business has seen a steady decline as more and more businesses and community users have been driven out either by scaremongering or literally being forced out and made to go elsewhere.

Prior to the takeover of Middlesbrough Council's Leisure Facilities in April 2016 several community groups were pushed out of Southlands into other centres such as the Neptune and Sports Village (over 50's, Stroke Group, Breathe-a-Cise etc.). None of these groups wanted to leave and would happily come back if the centre was to stay open. Many of the people who attended those sessions were my customers.

When the Council closed the gym and stopped putting on fitness classes in April 2016 a new Manager was brought in to run the community side of the centre. However, this person had no previous experience of running a centre such as Southlands and has done nothing whatsoever over the past two years to attract new businesses or users to the centre. His actual job title is Enterprise and Community Asset Transfer Manager which speaks volumes about the real reason why the Council put him in charge at Southlands. He was obviously brought in to oversee the closure of the centre by running it down, not to make it successful and profitable.

When the new Manager came in two years ago he should have had a plan in place to promote the centre and get the word out to the public that although the gym was closing, the centre itself was still open and had lots to offer. This was not done, in fact the complete opposite was done because the staff were initially told not to take bookings for parties etc. on the community side and no new businesses were allowed to come in. The Manager and therefore the Council were happy for the public to believe that the centre as a whole was no longer open, thus affecting the usage and occupancy levels massively.

For many years Southlands has been badly neglected, underfunded, mismanaged and not promoted properly and yet people still love the place and want to see it remain open. The building is badly in need of refurbishment but it is structurally sound and certainly not 'crumbling' as claimed by Mayor Dave Budd.

If the Council had not announced a year ago that they intended to close the centre by September 2017, the occupancy levels on the business side would be much higher than at present. Many businesses moved out as a direct result of the Council's action, not by choice. Almost all of those that left were regular customers of mine and this had a devastating effect on my business. In fact, the months between August 2017 and February 2018 were very difficult and it wasn't worth opening some weeks. During those months and in order to keep my assistant in a job I was actually working for nothing some weeks, and although the situation has now improved slightly, the business is only just surviving.

If Southlands does close then the Council will effectively be putting me out of business. Unlike the other business tenants who can relocate but still retain their customers, even though this will be traumatic and stressful for them, for me it would be like starting from scratch with all the risks that go with it. A customer base has to be built up over time and there is no guarantee that opening up elsewhere would prove successful, thus meaning that I may no longer be in a position to employ anybody else.

With regards to the sum set aside by the Council to help with relocation costs, I think they have underestimated massively the amount that would be required. Yet again they have just plucked a figure out of thin air but the actual cost is likely to be much higher than the £100,000 that they are quoting. The Council are very good at overestimating, for example the £200,000 cost of running Southlands that appeared in the 2017 report and in the Evening Gazette that was reduced to £122,000 when scrutinized, or the 8 years that they are saying it would take to get the occupancy level back up to 75% which is absolute rubbish, again just guesswork. Anybody who knows anything about Southlands knows that the building could be filled on both sides within a year if it is kept open and managed properly.

The Council claims to have worked tirelessly and made genuine attempts over the past two years to find a solution as to how to make the centre viable but they have done nothing of the sort. They have been trying to close the centre since Ray Mallon was Mayor. They do not carry out even basic repairs or maintenance, they do not employ staff who are capable of running the centre properly (from the Manager down), they do not promote the centre at all, and they do not listen to the public who do not want Southlands to be replaced by a 'fit for purpose community facility'.

The Council made the decision to close Southlands without having any discussions with the business tenants beforehand to see if anything could be done. None of the Labour Executive Councillors who were involved bothered to come along to speak to any of the tenants or the community groups to see how they would be affected if Southlands closes. Their decision last year was based on a report that was filled with inaccurate figures and information, and they have done exactly the same thing again now, relying on another report full of fake facts and figures.

After the decision was challenged a year ago, a group of business tenants, myself included, were meant to have been working with a group of Council Officers to try and work out a plan to keep the centre open. We were meant to have regular meetings and they assured us that they would be completely honest and transparent with us about what was going on. We actually only had 4 meetings in the space of a year, any information that we requested took weeks to be provided, the minutes of the meetings which were taken by one of their Officers were not always accurate and they took the first plan that we put forward as a starting point and used it against us to claim that we could not come up with a viable solution. Basically they completely misled us for their own ends and we were very foolish and naïve to trust them.

The past few years have been very stressful for everybody involved, both emotionally and financially. For me personally, the financial loss has been quite substantial and this is directly due to the Council's actions and those of the centre Manager in particular by driving out many of my customers. The situation has also put a strain on family life as the worry of closure has caused me many sleepless nights and the uncertainty has made it very difficult to plan for the future.

The Council and the Mayor in particular talk about having a 'vision' for Middlesbrough but they are being very short sighted by wanting to close Southlands and are missing out on a great opportunity to make the centre even better than it already is. The business and community sides work hand in hand to make it a unique place. Everybody who works here or uses the centre says how friendly it is and despite the state of disrepair that the building itself is in, people still want to come here. The Council should be proud of this centre and should be investing in it, not trying to demolish it. Centres like Southlands should not be about profit, although it could easily be very profitable with the right people running it. Southlands is a community within the community and the Council should be ashamed to even consider getting rid of it.

The closure of Southlands would be a massive loss for the community of East Middlesbrough and also much further afield. We have customers who come here for dance competitions and other big events from all over the north of England (Newcastle, Sunderland, Peterlee, Hartlepool, Doncaster etc.). I have spoken to hundreds, possibly even thousands, of people about this over the past two years and not one single person has said that closing Southlands is a good idea. It is about time the Council started listening to the people of Middlesbrough (and beyond) before it is too late.

Ref-Closure of Southlands Centre

My company has been located in the Southlands Centre for ten years. Within this term we have established a quality client base which will be adversely affected with us having to relocate.

The financial burden put on the company due to relocation is a worrying factor and I feel the proposed compensation package would not be sufficient for most companies to cover associated costs.

The possibility of reducing my staffs working hours would be very likely which would not only put a strain on the staff themselves but also on the day to day working efficiency of the business which would mean reduced profitability.

The process the council has gone through to get to this decision has been nothing less than shambolic. The tenants were supposed to be consulted on all proposal and developments but this has not been the case and we have been lead a merry dance with what has been happening throughout the entire process.

I have operated within the business centre for fifteen years and have solid roots to the centre. I took an office at the centre many years ago because of its location, easy parking and a well supported staff presence - I would've found it hard to make the business a success without the help, support and easy location of the centre.

With the uncertainty surrounding the centre I have not felt confident to expand, and it has definitely held me back. You could say why don't you just move? First of all, why should I? The alternative office in Middlesbrough town center has no parking and would definitely not suit my business needs and growth plans. I have made many business connections over the years and would find it very difficult to change all my contacts and details, accounts and banking letterheads to name just a few. My main concern of Middlesbrough Council is why do you think it is okay to close such an important business center without looking at the impact it will have on us the business owners. I have had no consultation from you and you clearly avoided any input from us.

The government have supported small business in our area with the closure of the steel works and have recognised that the best way forward for growth since the loss of the steel works is to help start up new businesses. I hope you will agree that small to medium business are the lifeblood of our town. Why do you not support us and start up businesses? You clearly do not support us. You have been very short sighted and have put long term gain under short term profit which is typical of labour councillors. Can I just add that the last thing our community needs is a community shed, or should I say hub, and more private housing.

#### Dear Councillor Hubbard

I can't begin to express how disappointed I am with the decision to close the Southlands Centre the whole process was a farce from people who lack honesty and integrity Over the last two years I have been placed under immense pressure and stress by Middlesbrough Council, first with the announcement the centre could close to the letters preempting the Executive Subcommittees decision last year telling us we had 6 months, notice before the executive members had even made the decision.

I have worked tirelessly with friends and other business owners to produce a viable and sustainable model to keep the centre open, all the while we have been told to work with targets of 75% occupancy despite the continued decline in occupancy because of Middlesbrough Councils own doing. We received assurances not to worry as this is your responsibility and so long as we worked to the 75% occupancy figures in producing our model, this would be acceptable.

Upon submission the doors were closed and we were not engaged further by officers to revise our proposals despite being told the 75% occupancy we'd been told to work too was not sustainable as it was significantly less. All of which, we had pointed out to the officers and asked if we can reduce the occupancy figures to demonstrate a sustainable model on lower tenancy numbers. This was rejected and we were told our bid was final.

The last call in 1 attend and spoke of my concerns, 1 even explained how officers had let the business owners down and we'd seen our businesses decline due to negative publicity about the future of the centre created by Middlesbrough Council. We received no active support to promote the centre as still been open and the centre manager was extremely passive in addressing this, he was seemingly more focussed on seeing the centre close. I suppose that is expected when you appoint an asset disposal manager to run a business centre the council has been considering closing for over 6 years now.

The council didn't even produce a business plan in case the centre remained open, that's how confident they were that it was closing and because of this alone I don't believe that a genuine attempt to keep it open even existed.

This will leave the town without an enterprise centre capable of competing with neighbouring towns, its as if they don't want the people of Middlesbrough to succeed. I also think the fund set aside to relocate us is ridiculous, I think that they think that we are moving house, well I'm afraid its a lot more difficult than that with a lot higher costs coupled with downtime and loss of income, I have estimated at £18,000 for my business alone.



All of this is has and is having a continued effect on my health with regular bouts of depression and anxiety

It has also had a huge impact financially, our competitors are now telling people that we are no longer trading because the Southlands has closed and our customers are looking elsewhere, this costs runs into the 1000's and will take years to get our name known again in a new place of business

Hopefully you can continue our fight in any way possible

Over the years I have been there I have seen a vibrant & extremely busy centre, where people were put on a waiting list for available space, degenerate to what it is now through the actions of Middlesbrough Council over the last 7 years to run the place down.

The uncertainty of these last few years has had a massive impact on businesses within the Southlands with many having already left. I have remained as I have built up a good reputation & am known throughout the area for what I do.

Re locating or "decanting" a term bandied about on the reports, seemingly so easy to say for those that don't have to do it, will be very upsetting & unsettling for me, also having to rebuild a following elsewhere when 21 years of association with the area & a place has to be reforged.

Moving will involve much extra work, time, expense & the stress & worry of all of this is taking its toll on my general wellbeing. I am having sleepless nights worrying over the outcome, where I am to go & how I am to afford new premises with the inevitable increase in rent coupled with the downtime to my business of a move & all that entails.

The council have mentioned an amount of money of £100,000, but divide that by the businesses remaining & it only amounts to under £3000. To re do my website alone would take up a large proportion of that, added to the removal costs, re marketing of my business with advertising, contacting my patients, flyers, letterheads, business cards & the downtime to do all of this & time taken to arrange it all.... the list goes on!

I am a sole trader & although I do not employ anyone I do bring in visitors from outside the area, these visitors use the local shops, petrol station, post office, cafe - in general boost the economy of the local area. This will all cease, there is bound to be an impact on the local economy from the closure of the Southlands. This is something the council don't seem to consider they just seem to have tunnel vision on savings in the short term & gaining money from an inevitable sale of the land to a housing developer.

There are still people setting up small business ventures to which the Southlands Business Centre, if restored to a reasonable state of order and repair and with commitment as an ongoing concern should still be a great opportunity. I despair to think that any council could neglect people battling against all odds to commence and sustain a business venture. As major companies fail it is us small guys that start out with a few job opportunities which make the difference in future employment statistics. Keeping people in employment is so important to the well-being of communities and the individuals living in them in terms of socio economic, health and well-being.
