Proposed decision(s)

That the Mayor:

• **APPROVES** consent being given to the amendment to the Adult Education Functions Order 2025 and the transferring of funding powers from the Department for Education to the Tees Valley Combined Authority for the technical qualifications.

#### Executive summary

This report seeks consent from the Mayor to a government planned devolution of additional powers to the Tees Valley Combined Authority (TVCA) in relation to Adult Education.

Devolution of these powers will enable TVCA to broaden the scope of training it is able to support.

## 1. Purpose of this report and its contribution to the achievement of the Council Plan ambitions

- 1.1 Consent of constituent authorities of combined authorities is required for the devolution of powers from public bodies to combined authorities. The purpose of this report is to seek that consent to enable government to lay an amendment to the Adult Education Functions Order 2025, before Parliament.
- 1.2 The Order will be made, subject to Parliament's approval, under provisions within the Cities and Local Government Devolution Act 2016, including section 105A, and will confer an additional funding power for adult education functions on all existing combined authorities with adult education functions. It will enable combined authorities to administer their Adult Skills Fund (ASF) to fund new technical qualifications from academic year 2025/26.
- 1.3 Due to errors in assumptions around the approval route for this by the combined authority, this decision has been requested with less than 5 days working notice and will also not be subject to call-in. The Chair of Overview and Scrutiny Board has agreed to this non-key decision being taken in these circumstances.

#### 2. Recommendations

- 2.1 That the Mayor:
  - **APPROVES** consent being given to the amendment to the Adult Education Functions Order 2025 and the transferring of funding powers from the Department for Education to the Tees Valley Combined Authority for the technical qualifications.

#### 3. Rationale for the recommended decision(s)

3.1 The recommended decision would appear to have no negative implications and does not bind TVCA to fund any particular qualifications, it simply broadens the scope of qualifications it may support. By not granting consent, the offer to students may be restricted with the TVCA area.

#### 4. Background and relevant information

- 4.1 The Department for Education (DfE) currently transfers statutory adult education functions to combined authorities via statutory instrument (once devolution deals are agreed) so they can decide, at a local level, which qualifications they wish to fund to support skills development in their areas.
- 4.2 This Order will amend the existing education-related statutory instrument for each Combined Authority to add the further funding power, specifically it will concurrently transfer Section 100(1B) of the Apprenticeships, Skills and Children Act 2009 (ASCLA), to enable combined authorities to fund new, high-quality technical qualifications alongside others already available to them. This will ensure that adult learners in the area will have access to the same high-quality technical qualifications as those in other devolved, and non-devolved, areas. The aim (subject to Parliamentary approval and timetabling) is for the statutory instrument to come into effect by the start of August 2025, in time for the new academic year.
- 4.3 This funding power will not be applicable for adults aged under 25 who are in receipt of an Education, Health and Care (EHC) Plan, as they will continue to be funded from the 16 to 19 budget, nor will it apply to adults in detention, as they are funded by the Ministry of Justice.
- 4.4 As part of the transfer process, DfE are required to undertake an assessment of new burdens. The purpose of the assessment is to keep the pressure on council tax bills to a minimum by ensuring that any new powers transferred to local authorities do not increase the administrative burden.
- 4.5 DfE believe that transferring section 100 (1B) will not place any additional burdens on combined authorities. This is because DfE are not imposing a duty on combined authorities to fund new qualifications, they are simply giving them the power to do so if they wish.
- 4.6 Qualifications are withdrawn and new qualifications are approved all the time, so the list of qualifications from which combined authorities can select is not static it is constantly changing. Commissioning officers and providers will already have processes in place to manage changes to the qualifications landscape and decide which ones are most appropriate for adults in their areas.
- 4.7 DfE are not asking combined authorities to do anything different, or change the way they operate, they are just giving them the power to fund the new technical qualifications, alongside other qualifications that are already available to them, if they want to.

#### 6. Other potential alternative(s) and why these have not been recommended

6.1 The Council could choose not to give the approval sought, which would result in powers not being devolved to the TVCA. DfE believe that if they do not transfer this funding power this may lead to a greater administrative burden.
