1. Summary of Application:

Members will recall that at it's meeting held on 28 March 2024, the Licensing Sub-Committee considered an application for a summary review of the premises licence for The Empire following a submission made by Cleveland Police.

A copy of the application made by Cleveland Police is attached at Appendix 1, and a copy of the existing premises licence for The Empire is attached at Appendix 2.

Having considered the summary review application at the above meeting, the Licensing Sub-Committee decided to suspend the Premises Licence as an interim step pending a full review hearing. The full decision and reasons are as follows:-

- 1. The Committee considered an application from the Police for a summary review of a Premises Licence in respect of the Empire, Corporation Road Middlesbrough which operates as a nightclub 11.00am until 4.00am daily.
- 2. Under Section 53A(2)(a) of Act, on receipt of such an application, the relevant licensing authority must within 48 hours of the time of its receipt, consider under section 53B whether it is necessary to take interim steps pending the determination of a review of the premises licence.
- 3. Under Section 53B(3) The interim steps the committee must consider taking are— (a) the modification of the conditions of the premises licence; (b) the exclusion of the sale of alcohol by retail from the scope of the licence; (c) the removal of the designated premises supervisor from the licence; (d) the suspension of the licence.
- 4. Section 53B(2) states the consideration of interim steps may take place without the holder of the premises licence having been given the opportunity to make representations, however, to ensure fairness, the premises licence holder was given the opportunity to make representations at this stage.
- 5. The Committee carefully considered the application, certificate and representations of the police and the representations and information provided by the Premises Licence Holder and its representatives.

Decision

- 6. The Committee decided that the suspension of the licence is a necessary interim step to alleviate the risk and to promote public safety and prevention of crime and disorder.
- 7. It did not consider that conditions proposed by the PLH or any additional conditions would immediately resolve the risk.
- 8. A very serious incident occurred at the premises, it was considered just luck that the customer did not suffer very serious injury if not worse. The perpetrator was the head door supervisor leading a team. A person in that position, whilst in his position of trust, forcibly threw a customer onto his head.
- 9. The Committee does not accept the PLH's representations that the management had no role, that it was fully compliant and it was only down to an unexpected out of character incident.
- 10. The premises was suspended after a full review in September 2022, the reasons included violent incidents in the premises as result of management failings and some involved door staff, there has been a subsequent violent incident in December 2023 where a door supervisor was arrested.

- 11. After this violent incident, the footage showed the head door supervisor and other door supervisors manhandling the customer from the road who appeared to be unconscious, which was dangerous, the perpetrator appeared to go back and forth, he did not appear to be challenged by staff. There appeared to be no system for aftercare, despite supervisors being first aid trained.
- 12. The DPS and business owner did not act appropriately, he was shown to come out twice but failed to intervene, take control, and appropriately manage the situation. This appears to be a pattern as shown in the previous review.
- 13. The incident record was severely lacking, it was not a true account, it did not have details of the assault or any aftercare, or signed and stated police action was not required.
- 14. The Committee did not accept the conditions proposed, It did not accept that a condition simply removing Hyena who have ran the security prior to the original review and up to a day or so before this hearing would immediately resolve the risk. There appeared to be no plan in any detail regarding how the operation will be ran in light of the incident, for this weekend.
- 15. The only material change is that Mr xxxxxx would replace the owner of Hyena with the same door staff remaining to provide security for the weekend, Mr xxxxxx actually consulted for Hyena in May 2022 which was a few months prior to the premises having to be reviewed in September 2022.
- 16. The Committee considers that a proposed condition to say Mr X will not be deployed at the premises to provide security is simply not sufficient. Nor was it clear what formal action (if any) was taken regarding Mr X immediately after the incident.
- 17. The Committee considered that having the DPS in the vicinity of the front of the premises would have little impact given he failed to act properly and take control on the night of the incident and that it appears the problems at the premises are management issues.
- 18. The Committee considered that no other conditions would be possible to reduce the risk.
- 19. The Committee did carefully consider the detriment to the operation but have decided to remove the risk to public safety and promote the prevention of crime and disorder by suspending the licence.

2. Legislation

The Licensing Act 2003 requires the Licensing Authority to carry out its functions with a view to promoting the four licensing objectives:

- The Prevention of Crime and Disorder
- Public Safety

- The Prevention of Public Nuisance
- The Protection of Children from Harm

The Licensing Authority must also have regard to its Licensing Policy and any guidance issued by the Secretary of State.

The Licensing Act 2003 provides a procedure for a summary review of a premises licence by the Police for an expedited or 'fast track' review of a premises licence which authorises the sale of alcohol in cases where a senior police officer of the rank of superintendent or above gives a certificate indicating that in his/her opinion the premises are associated with serious crime and disorder or both. The procedure allows the licensing authority to respond by taking interim steps quickly, where appropriate, pending a full review.

Should interim steps be imposed by the Licensing Authority the Licensing Act 2003 provides that the premises licence holder may make representations against the interim steps taken by the Licensing Authority. In this instance the premises licence holder has not made any further representations in respect of the interim steps taken to suspend the premises licence and the premises has remained closed since the hearing on 28 March 2024.

The Licensing Act also provides that the Licensing Authority must hold a full review of the premises licence and determine the review within 28 days after the day of the application for Summary Review made by the Police.

3. Consultation on review application

The premises licence holder, any responsible authority or any other person are permitted to make representations in respect of the review application following publication of a notice.

In response to the publication of the notice on 27 March 2024, 2 further representations were received.

On 4 April 2024 a representation was received from Fiona Helyer, Public Health Officer from Middlesbrough Council (Appendix 3).

On 3 April 2024 a representation was received from Jason Arbuckle, Licensing Enforcement Officer from Middlesbrough Council (Appendix 4).

Cleveland Police, Public Health and Middlesbrough Council Licensing have indicated that further evidence in support of their representation will follow shortly.

4. Background

These premises operate as a popular night club situated in Middlesbrough Town Centre in the hub of the night time economy. The premises have had the benefit of a premises licence under the provisions of the Licensing Act 2003 since 2005 and a Justices Licence and Public Entertainment Licence for many

years prior to that date.

On 05 May 2022 Cleveland Police submitted an application for Review of the Premises Licence following concerns in relation crime and disorder and underage sales at the premises.

Between 15 and 16 September 2022 the Licensing Committee considered the application, along with representations from a number of other Responsible Authorities and interested parties before deciding to suspend the premises licence for a period of 4 weeks with the addition of a number of additional conditions.

The Premises Licence holder subsequently appealed this decision to Teesside Magistrates Court, however, on 10 February 2023 a consent order was agreed between the Premises Licence holder and the Council which resulted in the premises licence being suspended for a period of 4 weeks with the addition of conditions. These conditions are detailed in the Premises Licence at Annex 3 (Appendix 2).

• Alternatively, Members may consider that it is not necessary to take any of the above steps and may issue an informal warning and/or or recommend improvement within a certain time period.

Any party to the hearing who may be aggrieved by the decision taken by the Licensing Sub-Committee would have a right of appeal to the Magistrates' Court.

The Police are asking for an Expedited Review following an incident on Saturday 23rd March 2024 at approximately 23:20 hours.

Police received information from the ambulance service, from a concerned member of the public who had witnessed a member of door staff from the Empire 'pick up a customer and throw him to the ground on his head resulting in him starting to fit'.

Subsequently CCTV footage of the incident has been circulated via social media showing the incident.

The footage clearly shows the door supervisor picking up the male and throwning him to the ground on his head.

It is concerning that the male appears to be unconscious and is given no aftercare. The footage shows the male being dragged off the road by two door supervisors without any regard for potential significant injuries.

A door supervisor from the premises has subsequently been arrested for the offence of Section 18, intent to cause grevious bodily harm (GBH), and is on police bail.

This is not an isolated incident. There have been previous incidents involving serious crime and disorder at the premise, some involving staff members. In September 2022 the premises licence was reviewed by Middlesbrough Council following concerns in relation to serious violence at the premises.

This latest incident constitutes both serious crime and serious disorder. Cleveland Police does not believe it is appropriate to address these issues through the standard review process as the incident is serious and involves a staff member, and any delay as a result of such a process being followed, would be disproportionate to the risk of another victim being seriously harmed. Cleveland Police believe that Immediate Action is required to prevent further risk to the community.



Annex 1 - Mandatory conditions

Supply of Alcohol

- 1. No supply of alcohol may be made under the premises licence:
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Exhibition of Films

- Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- 4. Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation made by that body.
- 5 Where-
- (a) The film classification body is not specified in the licence, or
- (b) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.
- 6. In this section "Children" means persons aged under 18; and "Film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

Door Supervision

- 7. Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, that licence must include a condition that each such individual must:
- (a) Be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001;
- (b) Be entitled to carry out activity by virtue of section 4 of the Act.
- 8. But nothing in subsection (1) requires such a condition to be imposed:
- (a) In respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with premises licences authorising plays or films); or
- (b) In respect of premises in relation to:
- (i) Any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
- (ii) Any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- 9. For the purposes of this section:
- (a) "Security activity" means an activity to which paragraph 2(1) (a) of that Schedule applies, and which is licensable conduct for the

purposes of that Act.

(b) Paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Age Verification

- 10. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- 11. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- 12. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:
- (a) a holographic mark, or
- (b) an ultraviolet feature.

Permitted Price

- 13. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 14. For the purpose of this condition set out in paragraph 1:
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula-

P = D + (D X V)

Where:

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) 'relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or

officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 15. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 16. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Irresponsible Drink Promotions (applicable to 'on' & 'off' sales)
17. The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

- 18. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises:
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to:
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise).
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise antisocial behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

19. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Alcoholic Drink Measures

20. The responsible person must ensure that:

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
- (i) beer or cider: 1/2 pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

1. CCTV SYSTEM

A digital Closed Circuit Television System (CCTV) will be installed and maintained in good working order and be correctly time and date stamped:

- the system will incorporate sufficient built-in harddrive capacity to suit the number of cameras installed;
- CCTV will be capable of providing pictures of evidential quality in all lighting conditions, particularly facial recognition;
- cameras will encompass all ingress and egress to the premises and all areas where the sale/supply of alcohol occurs and all outside areas:
- CCTV cameras will cover the entrance areas and queuing areas
- the system will record and retain CCTV footage for a minimum of 28 days;
- the system will record for from opening until close of the premises;
- the system will incorporate a means of transferring images from the hard-drive to a format that can be played back on a compatible computer;
- the Digital recorder will be password protected to prevent unauthorised access, tampering, or deletion of images;
- there will be at all times, when the premises is open, a member of staff on duty with access to the CCTV system who is trained in the use of the equipment;
- upon receipt of a lawful request for a copy of CCTV footage from Police, Licensing Officers or any other Responsible Authority, the member of staff will produce the footage within 24 hours, or less if urgently required for investigations of serious crime;
- CCTV footage must be made available to be viewed by the Police, Licensing Officers or other Responsible Authorities on lawful request during an inspection of or visit to the Premises.

2. CCTV Monitored

A member of staff will be designated to monitor the CCTV screens. They shall have the ability to contact and liaise

with both staff and the door security team.

3. CCTV screen at Reception

A TV screen will be installed in reception, above the pay desk. The screen will show a picture of the reception area focusing on facial recognition of customers entering the premises, so that customers' attention is drawn to the fact that they are on CCTV.

4. Entrance Area and queuing area

The entrance area and any queuing areas will be sufficiently lit to enable the areas to be clearly visible to staff and for CCTV to capture clear footage.

5. Outside Lighting

Adequate lighting will be installed on the exterior of the premises to ensure the area is sufficiently illuminated to be able to be visible to staff and for CCTV to capture clear footage covering those areas.

6. Cleaning the outside area

The area immediately outside of the premises will be cleaned regularly.

7. Removing Disorderly Customers

The premises licence holder will ensure that individuals who are drunk, disorderly or both will not permitted to access to the premises.

Any person who is drunk or disorderly within the premises will be removed from the premises

Door Supervisor Register

The premises licence holder is to maintain a door supervisor register. This will contain name, address, SIA badge numbers Door staff will sign on duty at the start of the shift and off duty when they leave.

9. Door Supervisor Numbers

The premises will have in place adequate SIA registered security for evenings when open to the public, to an approximate ratio of 1 door supervisor to 100 patrons.

10. Body cameras

When the premises is open, a body camera device will be worn by at least 5 door supervisors or worn by 50 % of the number of door supervisors on duty at the time, whichever is the greater. The head door supervisor will be one of the door supervisors who wears a body camera device.

If an event requires less than five door supervisors on duty then all door supervisors on duty at that event shall wear a body camera device. 11. Manager and Door Team Communications

The premises manager is to be connected to the door team at all times on the premises radio system.

12. Containers

Patrons or customers will not be permitted to enter or leave the premises with any glass bottle or other open container

13. First Aid

A fully qualified first aider will be on the premises during the hours of operation.

14. Street Marshalls

Door Supervisors and the Management Team shall work with Street Marshalls when they are deployed adjacent to the premises.

15. Leave quietly

Prominent notices will be displayed asking customers to leave the premises quietly.

TRAINING

16 Training of All Staff

Training must be provided to and undertaken by all staff before they commence their duties and at least every six months thereafter.

Training should include but is not limited to the following areas:

Promotion of the Licensing Objectives

Challenge 25, underage sales and the protection of

children and young people

Drunkenness

Recognising vulnerability in customers and Safeguarding

The Premises' Risk Assessment The Premises' Policies on

Health and Safety

17. Training Record

A training record of all members of staff will be maintained and capable of being produced immediately to any Responsible Authority.

The Training Record must include the name of the member of staff, date time and content of the training and signed by the member of staff receiving the training and the manager of the premises

18 Training of Door Supervisors

In addition to the training in condition 16 above, and training provided as part of the SIA Licence, Door Supervisors must receive training on the use of hand held metal detectors, the Scannet sytem, searching and the

implementation and operation of the Premises Licences Policies.

That training should be updated and carried out every six months

The Training should be documented to include the name of the door supervisor, date time and content of the trianing, signed by the door supervisor and the trainer and made available to the Police or Licensing Officers on request or during an inspection.

19. Incident Book

An incident book must be kept at the Premises and maintained up to date (no later than 24 hours after the incident) at all times, and will record the following:

- time date and details of all incidents/complaints of crime and disorder or anti-social behaviour;
- all crimes reported to the venue;
- all ejections of patrons;
- all seizures of drugs or offensive weapons;
- any faults in the CCTV system, searching equipment or scanning equipment;
- any visit by a relevant authority or emergency service.

The incident book must be made available to Police, Licensing Officers and all other Responsible Authorities on request or during an inspection.

20. Fire Risk Safety Assessment

The premises licence holder will undertake a fire risk assessment which will be shared with the fire department and Cleveland Police. The fire risk assessment will be made available to any responsible authority immediately on request.

Any use of pyrotechnics must be included within the relevant fire risk assessment and shared with the Fire authority if requested.

21. Minimum of Two Personal Licence Holders

A minimum of 2 personal licence holders will be on the premises when the premises operates.

22. Provision of a Weekly Report to the Police

The premises will email to the police a weekly report of incidents, proposed bans, door staff employed and customer numbers, so that the police can easily gauge whether there is an escalation in crime and disorder associated with the premises. This will continue until the police confirm it is no longer required. It can then be reimplemented upon police request.

Debrief at the end of each

There shall be a debrief at the end of each trading period

between a manager and the head doorman. Such debriefs will be documented and used to inform the weekly report provided to the police.

Persons under 18 years of age are not allowed on the premises other than at an under 18s event or on Middlesbrough Football Club matchdays.

- In the case of Middlesbrough Football Club matchdays:
 - i. All children must be accompanied by an adult and.
 - ii. Must leave the premises by 8pm.
- 2. In the case of an under 18's event:
 - i. The event will take place between 12 Noon and 10pm
- ii. A fully qualified paramedic shall be on the premises.
- iii. The age range of patrons shall be limited to 14 to 17 year olds only.
- iv. Only soft and non alcoholic drinks shall be sold or be on display.
- v. If any patron is found to be under the influence of drugs or alcohol then their parents or guardian shall be contact and asked to collect the child or children. The management will not turn away patrons without ensuring they are safe and are able to be collected by a parent or guardian.
- vi. Random searches are made of any patron wishing to gain access to an Empire under 18 event. Refusal to allow search will result in refusal of entry.
- vii. Any patrons found to be intimidating other patrons, pushing or shoving or attempting to jump the queue will not gain entry. Any patron found fighting or using bad language will be escorted out of the venue and a parent or guardian called to pick them up.
- viii. Patrons will be allowed into the premises with cigarettes if they are over 16 (and have proof of age) Cigarettes are not sold at the event and any cigarette machines are turned off for the event
- ix. A professional registered security team all having had criminal records check for suitability, will be on hand to assist anyone at all times and Empire Security will also be available to assist and answer any questions.
- In addition to the above conditions regarding under 18 nights:
 - On any Sunday, Monday, Tuesday, Wednesday or Thursday over 14's will be admitted to the premises, they will also be admitted on 4 occasions throughout the year

to events held on Fridaysor Saturdays, with prior consultation with Cleveland Police, providing the following additional conditions apply:

- all customers will be given a secure wristband of differing colours, differentiating under 18's from over 18's;
- the theme of the night will be live music event;
- all drinks will be served in plastic glasses.
- a First Aider will be on the premises throughout the night;
- if any patron is found to be under the influence of drugs or alcohol then their parents or guardian shall be contacted and asked to collect the child or children.
- ii. The management will not turn away patrons without ensuring they are safe and are able to be collected by a parent or guardian

25. Challenge 25

The premises licence holder shall adopt a Challenge 25 scheme.

Appropriate signage will be placed at the entrance to the premises and adjacent to any bar servery.

Any person attempting to buy alcohol or attempting to gain entry to the premises who appears to be under the age of 25 shall be required to provide ID for staff or door supervisors to verify the person is over 18 before entry to the premises is permitted or a sale of alcohol is made. The only acceptable ID is a current ten year passport, photo card driving licence or PASS Hologram identity card.

26. Scannet

The premises will operate a Scannet ID system (or similar) at all times the premises is open to the public. The system will be used in accordance with Challenge 25 scheme, and anybody providing ID in accordance with Challenge 25 will do so in conjunction with the machine. If the machine malfunctions the premises will notify the Licensing Authority and the system will be fixed or replaced within 28 days.

This representation is being made by the Responsible Authority for Health on the grounds of crime and disorder, public safety, and the protection of children from harm to support the application made by Cleveland Police for review of the premises licence in respect of The Middlesbrough Empire.

The Middlesbrough Empire is a well- known nightclub in Middlesbrough that attracts a high proportion of night-time revellers to Middlesbrough town centre on a weekly basis. These premises are situated on Corporation Road, Middlesbrough. A premises licence is in place which allows licensable activities to take place, including the sale of alcohol, between the

hours of 11am - 3.30am, seven days a week.

In September 2022 a Licensing Sub Committee was held following a number of serious incidents occurring at the premises including a stabbing of a 19-year-old male. Person(s) arrested were found to be all under the age of 18 years. There were also concerns around persons under the age of 18 years being allowed to frequent these premises for the purpose of consuming alcohol and concerns around the doorstaff operating at the premises.

Middlesbrough Council's Licensing Committee heard evidence from Cleveland Police, Public Health, and Licensing representatives as to their concerns. Following this, a full committee report was produced which included the outcome of the hearing (Exhibit Ref FMH/1).

On 26 March 2024, Cleveland Police applied for an expedited review following a further serious incident that occurred at the premises on Saturday 23 March 2024 involving a member of the doorstaff team. During this incident the member of doorstaff was seen to pick up a young male, placing him in the upside-down position before forcibly throwing him to the ground on his head. Members of the doorstaff team were then seen to drag the young male by his clothing whilst he was clearly unconscious, placing him onto the pavement before walking away.

Members of the doorstaff and management team failed to provide any immediate first aid and care to the injured male and/or contact emergency services for help.

On 22 March 2024, I along with a member of Cleveland Police had cause to attend Middlesbrough Empire to carry out follow up enquiries for a further incident that had occurred during a 14+ Bad Boy Chiller Crew event that had been held at the premises on Saturday 16 March 2024. As this was a 14+ event, children aged 14-18 years were allowed entry to the premises.

During this event a young 16 year old male who had been drinking at the premises and was intoxicated, assaulted another young customer before leaving the premises. When outside of the premises the same male hit the window of a passing taxi that was transporting passengers, causing the glass window to smash, showering the passengers in glass. He then went on to damage an ambulance that had been called to the premises to help another young customer inside of the premises before assaulting a Police Officer.

On 15 December 2024 I was in attendance at the front door of the premises with Police and Community Safety Officers when a fight spilled out onto the street from inside of the venue. This incident left the injured party needing hospital treatment for missing teeth and a suspected broken nose and jaw bones.

Such incidents impact massively on all blue light services including Ambulance, Police and local Accident and Emergency departments.

Data received from Middlesbrough Council's Safe Haven Service indicates that the medical team have tended to several incidents of alcohol related violence, intoxication and/or substance misuse that have taken place at The Empire.

It is apparent that there are still ongoing issues at these premises since the last review and that the safety of the public is being put at risk. The information provided above demonstrates the extent of the risks to public safety presented by this premise., in terms of the extent of the injury, treatment required and the demands which have been placed on the Emergency services and hospital resources, all of which raise serious concerns.

It is the responsibility of the Premises Licence Holders/Designated Premises Supervisors and all staff working at the premises including doorstaff to ensure that they uphold the law and the licensing objectives and provide a duty of care to anyone visiting the premises. It is clear from the latest serious incident that the licensing objectives have been undermined and that there is a clear lack of control at these premises.

Further evidence will be submitted prior to any future licensing sub-committee hearing

These premises are situated in Middlesbrough Town Centre which has a high density of licensed premises and already suffers from high levels of alcohol related crime and disorder and anti-social behaviour.

Middlesbrough Council Licensing Unit have serious concerns in relation to the operation and management of these premises. We have concerns regarding the incidents of violence that occurring in and around the premise some involving members of door staff which places others at serious risk of harm.

The incident on the 23rd of March 2024 which prompted Cleveland Police to instigate a summary review of the premises licence is of great concern as it shows excessive violence and a clear lack of control and restraint from the Door Supervisor in question. CCTV evidence also shows a complete lack of aftercare given to the victim by both Door Supervisors and management of the premise.

These premises were previously subject to a Review hearing in September 2022 following concerns in relation to violence and the admission and sale of alcohol to persons under 18.

Since the Review of the premises License in 2022, Middlesbrough Council have received further reports from a number of sources which suggest that children are still attending the premise.

Middlesbrough Council are also concerned about the continued poor management of the premises, and the management of staff at the Premise.

Further information in support of this representation will be presented in due course.
