#### 23/6 WELCOME AND FIRE EVACUATION PROCEDURE

The Chair read out the Fire Evacuation Procedure and welcomed all present to the meeting.

There were no Declarations of Interest at this point in the meeting.

#### 23/8 MINUTES- STANDARDS COMMITTEE - 8 JULY 2024

The minutes of the Standards Committee meeting held on 8 July 2024 were submitted and approved as a correct record.

#### 23/9 QUARTERLY UPDATE REPORT TO STANDARDS COMMITTEE

A report of the Director of Legal Services was presented by the Deputy Monitoring Officer, to provide a quarterly update to the Standards Committee in relation to the recent and current position concerning Code of Conduct Complaints.

There were 59 complaints in 2023. Of those complaints 9 were withdrawn or discontinued, 30 were advised to be rejected based on the assessment criteria, 14 were resolved informally by way of advice and guidance and 6 were being investigated.

In relation to 1 of those 6 complaints, information was awaited from external sources to finalise the investigation. The remaining 5 complaints related to the same social media incident and the same Member, which were being investigated along with subsequent complaints of a similar nature in 2024, to ensure the issues were considered as a whole.

There had been 12 complaints so far in 2024. Six complaints had been rejected, and 6 complaints had been accepted. Out of the 6 accepted complaints, 3 related to the same Member in relation to social media posts and were being considered together with complaints made in 2023. Two complaints were received in relation to a Member's social media posts and 1 complaint was again in respect of a Member's social media post and comments made.

Although complaints were logged separately, the statistics and information could show how separate complaints might relate to the same incident or subject matter, which had caused concern to a number of Councillors and/or members of the public.

As discussed previously at Standards Committee, the common prevalent theme of the complaints was inappropriate use of social media. Training was therefore being identified and organised in relation to the Council's social media policy, social media use and the impact on Members' Code of Conduct. This included the use of private social media accounts where a Member could be acting in their capacity as a Councillor.

It was accepted by the Deputy Monitoring Officer that there had been delays in relation to processing standards complaints to their completion. The delays were generally due to staffing changes within the Directorate and were currently being addressed. A locum Governance Officer had been appointed for a set period to look at the Constitution and governance, and also to review the process for standards complaints.

Members raised issues in relation to the timelines for processing standards complaints and

multiple complaints in relation to the same Members.

#### AGREED as follows that the:

- 1. the information provided was received and noted.
- 2. Deputy Monitoring Officer would provide statistical information at the next meeting in relation to the numbers of Members who had multiple complaints made against them.

#### 23/10 LOCALISM ACT 2011 - GENERAL DISPENSATION

A report of the Director of Legal and Governance and Monitoring Officer was presented, the purpose of which was to enable a general dispensation to be granted to those Elected Members who had applied for a dispensation in respect of matters that might affect so many Councillors that the Council or Committee would be inquorate.

Councillors L Henman and L Young had both requested a dispensation. The dispensation would allow both Members to participate fully in a meeting whenever the following matters were discussed:

- a) Housing; where the member (or spouse or partner) holds a tenancy or lease with the Council as long as the matter does not relate to the member's particular tenancy or lease;
- b) Housing Benefit; where the member (or spouse or partner) receives Housing Benefit;
- c) Statutory sick pay; if a Councillor receives this or is entitled to receive it;
- d) An allowance, travelling expense, payment or indemnity for Councillors;
- e) Any ceremonial honour given to members.

#### AGREED as follows that:

- Standards Committee granted a general dispensation to Councillors L Henman and L Young in respect of matters that might affect so many Councillors that the Council or Committee would be inquorate.
- 2. The general dispensation be applied for the maximum permitted period of 4 years from the date of this decision.

4.1 This report is provided to committee members to give an overview of the current, and recent position with regards to the Code of Conduct complaints received

- 4.2 There are no outstanding complains from 2020, 2021 and 2022.
- 4.3 There were 59 complaints in 2023. Of those complaints 9 were withdrawn or discontinued, 30 were advised to be rejected based on the assessment criteria, 14 were resolved informally by way of advice and guidance. 6 complaints which have

- been accepted are ongoing, 5 of those complaints relate to the same member and are linked with similar ongoing complaints made in 2024.
- 4.4 There were 21 complaints in 2024. Of those complaints 9 were rejected, 10 have been accepted and 1 is ongoing. The 11 complaints that have not been rejected are currently being considered as to how they should proceed.
- 4.5 There have been 9 complaints so far in 2025, 2 are ongoing, 6 have been rejected and 1 complaint was accepted but resolved informally by advice and guidance.
- 4.6 The statistics and information can show how separate complaints may relate to the same incident or subject matter, which has caused concern to several Councillors and / or members of the public, rather than the numbers reflecting wholly separate incidents.
- 4.7The common prevalent theme of the complaints is inappropriate use of social media. Training was therefore identified and carried out by the Local Government Association to Members on the 4 February 2025. Ten Members attended the training. The theme of complaints will be continued to be monitored to consider whether the training should be repeated.
- 4.8 It is acknowledged there are a number of outstanding complaints from 2023 and 2024 to resolve which require prioritisation. An update on the progress of the outstanding complaints will be provided at Standards Committee. The Monitoring Officer has secured growth in the budget to employ a full-time, permanent governance solicitor to assist and support in standards matters. The recruitment process is underway.

## **Executive summary**

The Council is continuing to deliver its governance improvement programme, which included reviewing its constitution and scheme of delegations. This work is being led by the Constitution and Member Development Committee ("CMDC") in respect of the Non-executive functions and the Executive in respect of the Executive Functions.

Officers and Members each have a key role to play in this process to ensure the constitution and delegations reflect the law and local custom and practice. CMDC has set up a working group to ensure that the review of the constitution is delivered in a timely fashion and hits the timeline set out for the review.

It is intended that the refreshed constitution is presented to Annual Council on 21 May 2025 for adoption. This report invites Standards Committee to consider the proposed changes to the Constitution at Section 8 in respect of presentation of the Standards Function.

## 1. Purpose

1.1 The Constitution and Member Development Committee ('CMDC')has been reviewing the provisions of the Constitution to remove duplication and improve its usability as far as possible. It is proposing to amend Section 8 of the Constitution (Standards) and seeks the input of the Standards Committee as a result.

#### 2. Recommendations

- 2.1 That the Standards Committee:
  - 2.1.1 consider and discuss the proposed revised Standards Section of the Constitution;
  - 2.1.2 provide any comments in respect of the proposed revised Section 8 of the Constitution to the Constitution and Member Development Working Group forthwith;

## 3. Rationale for the recommended decision(s)

- 3.1 The refreshed constitution provides a detailed glossary of terms and it is therefore important that the constitution applies these terms consistently throughout.
- 3.2 There is no requirement for Standards Hearings Arrangements to be included in the constitution therefore it is proposed these are extracted from the constitution and made available via the website.
- 3.3 The Member Code of Conduct is a cornerstone of good governance within the Council and therefore should be afforded greater visibility in the constitution, hence the suggestion it is included at Section 8 of the constitution.

#### 4. Background and relevant information

4.1 The Council has recognised that improvements can be made to its governance processes, as set out in the corporate governance improvement plan, with particular reference to the refresh of the Constitution to ensure that it is accurate and current.

#### Constitution

4.2 The Council adopted a revised constitution format in May 2023, intended to make the constitution more accessible and user friendly. The Constitution is a living document that evolves continuously to reflect the ever changing environment in which the Council operates – nationally, regionally and locally. The Monitoring Officer therefore has ongoing responsibility for ensuring that the Constitution remains accurate and lawful, and has delegated authority to make some changes,

- which are then reported to the next meeting of Council. More fundamental changes are approved by full Council.
- 4.3 Since the updated Constitution was adopted issues of duplication and inconsistency have been identified, which is usual given the dynamic and complex environment in which the Council operates. The whole Constitution is therefore being reviewed as one coherent document with a view to ironing out any duplication or inconsistency and ensuring that the Constitution appropriately reflects the Council's governance and operating arrangements.
- 4.4 Most of the work on the constitution refresh is being reviewed through the Constitution and Member Development working group (CMDWG) however, where appropriate, views are also being sought from Officers and Members to ensure that any revisions are appropriate.
- 4.5 The views of Members will also be sought throughout the process to ensure they are comfortable with the proposals this will be achieved via a member briefing before the Annual Council and the last CMDC, and by reports going to relevant committees in respect of proposed amendments.
- 4.6 To date, the CMDWG has considered and accepted:
  - (a) Section 1 Introduction
  - (b) Section 2 Constitution
  - (c) Section 3 Citizens and the Council
  - (d) Section 4 Council (including Council Procedure Rules)
  - (e) Section 7 Overview & Scrutiny
  - (f) Section 8 Standards

#### Section 8

- 4.7 Attached as Appendix 1 is the "roadmap" document approved by the CMDWG in respect of the section reflecting the Council's Standards provisions, section 8. This sets out what the current provisions of the constitution are as well as the proposed provisions.
- 4.8 The Standards Committee is invited to consider the proposed Section 8 of the Constitution and provide comments on the same to the CMDWG.

# **Constitution Roadmap**

## How the roadmap of the constitution works

The roadmap for the constitution has been designed to display the existing constitution, its issues and the proposed solution. The columns

- Column 1 URN the Unique Reference Number given to each row of the roadmap so that they all have a unique number whichever section of the constitution you are looking at. This number will however change as additions and deletions are made to the document which is why it is the last column to be populated.
- Column 2 Section the section of the current constitution that is being considered.
- Column 3 Para No. the current paragraph number of the constitution this becomes less helpful through the constitution if divorced from the section number given that the numbering reverts to 1 at the beginning of each later section of the constitution.
- Column 4 What it says this is where the current constitution is set out.
- Issue the first part of this section sets out what the issues or concerns are about the EXISTING section of the constitution set out at paragraph 4. If no changes are required, that will be confirmed here. Alternatively, it may say there are minor changes for style / readability / consistency. If the changes proposed are more fundamental, the reasons why will be set out in more detail here, and may include potential options for resolution and confirm what the URN of the new constitution is where the existing provision now sits.

The second part of this column deals with the next sequential paragraph of the NEW constitution as set out in column 6. When changes are being made to harmonise and simplify the constitution, there is no way to keep the existing constitution and the new constitution paragraphs married up, particularly given that the Council has asked

that the constitution only contain provisions once, to assist with amendment of the document. There is therefore substantial cross referencing in the proposed constitution to reduce duplication.

The second section is not required in Section 1 of the constitution due to the minimal nature of the amendments required to it.

Column 6 Proposed Solution – this is the column which contains the proposed revised constitution. The rationale for this paragraph is set out in the second section of column 5.

The "track change" Word version of the constitution, showing the actual changes (deletions, additions, moved sections etc.) is available upon request however the CMDWG has requested that all future meetings focus on the Roadmap document so everyone is working on the same document, making it easier to manage the meetings and comments.

Members have both an individual and collective responsibility to meet these expectations by maintaining high standards and demonstrating good conduct, and by challenging behaviour which falls below expectations.

8.9.3 Importantly, Members should

be able to undertake their role without being intimidated, abused, bullied, or threatened by anyone, including the general public.

8.9.4 The Code of Conduct has been designed to protect the democratic role, encourage good conduct and safeguard the public's trust in local government. All councils are required to have a local Member Code of Conduct.

8.9.5 The purpose of the Code of Conduct is to assist Members to model the behaviour expected of them, to provide a personal check and balance, and to set out the type of conduct that could lead to action

8.9.42 As a Member:

- (b) I register with the Monitoring Officer any gift or hospitality with an estimated value of at least £25 within 28 days of its receipt.
- (c) I register with the Monitoring Officer any significant gift or hospitality that I have been offered but have refused to accept.

However, Members do not need to register gifts and hospitality which are not related to their role as a Member, such as Christmas gifts from friends and family. - 4.1 The Council's Code of Conduct requires Councillors and Co-opted Members to declare and register the receipt of either gifts or hospitality with a value of £25 or more. The Monitoring Officer is required to establish and maintain a register in relation of gifts and hospitality and to produce a report to Standards Committee, on an annual basis, outlining details any gifts and hospitality received by members and officers of the Council.
- 4.2 Members register their interests in three ways:
  - By completing an annual declaration of financial and personal interests. These
    interests are published on the Council website under each individual councillor's
    profile. Your Councillors | Middlesbrough Council
  - By making declarations at meetings where they have interest in a matter to be considered at that meeting. Declarations made in such circumstances are recorded in the minutes of those meetings and are entered in the Register of Disclosures and General Notices.
  - By declaring and registering when receiving either gifts or hospitality with a value of £25 or more. The declaration should include details of the gift or hospitality, its approximate value and details of the person or body that provided it. Although not a requirement, Members also occasionally register gifts or hospitality of lesser value.
- 4.3 Declarations are entered in a Register of Gifts and Hospitality.

Details of entries received from Officers for the period January 2024 – December 2025 are attached at Appendix B.
